ISSUE FACT SHEET

INAPPROPRIATE EDUCATIONAL MATERIALS IN PUBLIC SCHOOLS

<u>**CONSERVATIVE ARGUMENT</u>**: Pervasively vulgar, sexually explicit, educationally unsuitable and/or other obscene materials have no place in public schools and must be removed.</u>

FACTS:

- Obscenity is not protected under First Amendment rights to free speech, and violations of federal obscenity laws are criminal offenses.

- Over the last year, concerned parents and citizens of Gillespie County and across the nation began finding these types of materials in school libraries and classrooms and started to speak out at school board meetings against them.

- These materials number in the hundreds in the elementary, middle school, and high school grades. The "Matt Krause List" records over 800 books that are potentially harmful for children.

- FISD agreed that 10 books submitted by parents are indeed pervasively vulgar and not educationally suitable for children. These challenged books are not a 1st Amendment right, but they are an attack on children and our moral decency as human beings. This massive library search is just beginning here in Fredericksburg.

- There are existing laws within the state of Texas to protect children and parental rights, such as the Texas Family Code 151 and the TEC Chapter 26, but these rights are being largely ignored by school board trustees, school district administration, and some left-leaning schoolteachers and librarians.

- One such law, Texas Penal Code 43.24, **Sale, Distribution or Display of Harmful Material to Minors**, prohibits the dissemination of materials deemed harmful to minors, which is defined as material whose dominant theme taken as a whole: (A) appeals to the prurient interests of a minor in sex, nudity, or excretion; (B) is patently offensive to prevailing standards in the adult community as a whole with respect to what is suitable for minors; and (C) is utterly without redeeming social value for minors, <u>**but**</u> it also includes an affirmative defense to prosecution if the sale, distribution, or exhibition was by a person having scientific, <u>educational</u>, governmental, or other similar justification. The leftists are using this loop-hole in

the law claiming that these inappropriate materials are "educational to the students" and therefore, the obscenity exemption for educational purposes MUST BE REMOVED.

- In March 2022, FISD Superintendent, Dr. Rodriguez, introduced local school board policy concerning instructional materials at FISD schools: "Materials that are determined to be factually inaccurate, pervasively vulgar, not educationally suitable, or inappropriate in light of the age, maturity, and impressionability of the student audience may be removed prior to the reconsideration committee's completed review." The FISD School Board approved these policies in a vote 7 to zero.
