TREASURER'S REPORT - Bob Hoag

Financial Reports - Comments on Financial Reports for the nine months ended September 30, 2023. Reviewed highlights of first two sheets, summary of the Balance Sheet and Income Statement. Balance Sheet looks at assets and liabilities at a point in time. We have received the fourth quarter stipend from the Town. The stipend is received quarterly and brought in monthly in line with accrual accounting.

Our Vanguard investments have continued to go up since last year. The investments have done very well. There are two purposes of the Vanguard investments: 1) as a contingency fund if there is a significant financial shortfall, and 2) as a source to provide senior center furnishings for a new community center.

There is still some grant money available. The freezer and dishwasher are both installed.

The positive net income is due to investments and donations. Operations were a loss.

The Finance Committee is looking at producing a cash flow report.
