## A Few Thoughts for the Tutor

The number of localities in which *Reflections on the Life of the Spirit*, the first book of the main sequence of courses offered by the Ruhi Institute, is studied throughout the world has been on the rise for many years. In the vast majority of cases, the material is read and discussed by a group of friends, who may constitute a study circle that meets regularly, may come together in a campaign arranged for intensive study, or may gather in a camp during school holidays. Whatever the occasion, one member of the group acts as a tutor. The relationship between the tutor and the other participants is not one of teacher-to-student; all are consciously engaged in a process in which everyone is seeking to learn. But the tutor is not a detached and passive facilitator of discussion either. Having completed a sufficient number of courses in the sequence and undertaken the acts of service they encourage, he or she is able to assist every member of the group in achieving the purpose of the material being studied. Those who act as a tutor of Book 1 may find it helpful to review the ideas presented in this introduction from time to time.

Participants worldwide come to this first institute course from diverse backgrounds. Some are already members of the Bahá'í community who hope to enhance their capacity to serve the Cause they have embraced. Others see the course as the beginning of their investigation of the Bahá'í Faith as a religion. Still others are attracted to Bahá'í ideals and wish to acquaint themselves with the community's aims and endeavors. And there are an increasing number of young people in particular who, wanting to develop their capacity to serve society, often through one or another program promoted by the Bahá'í community, take the course as an initial step.

From the outset, it should be clear to every participant that the courses of the Ruhi Institute trace a path of service to humanity, upon which we each walk at our own pace, assisting and being assisted by others. Treading this path implies the pursuit of a twofold moral purpose: to attend to one's own spiritual and intellectual growth and to contribute to the transformation of society. Progress on the path entails the development of a number of capabilities that require understanding and knowledge, spiritual qualities and praiseworthy attitudes, as well as a host of abilities and skills. The sources of knowledge upon which the books of the Institute draw are, on the one hand, the teachings of the Bahá'í Faith and, on the other, the accumulating experience of the worldwide Bahá'í community in furthering material and spiritual civilization. It is Bahá'u'lláh's vision of the individual we can become and of the civilization we can build that inspires the Institute. It is assumed that all participants, independent of background, are open to embracing this vision, which is explicit in every unit of every book.

In a world where creeds and ideologies are willing to employ any means possible to win adherents, someone unfamiliar with the Faith may have genuine questions about the intentions of the Ruhi Institute, most notably, "Am I being asked to change my religion?" or "Am I being asked to join a religion?" Such questions offer the tutor a chance to explain the purpose of the sequence of courses as outlined above. While it is natural that Bahá'ís would

be eager to see their friends join the community, their own teachings prohibit them, a tutor may wish to add, from engaging in proselytization. Walking the path of service opened up by the institute courses calls for an ever-deepening understanding of Bahá'u'lláh's teachings, which the materials endeavor to set forth unequivocally; acceptance and faith are matters to be contemplated by each individual freely and without pressure.

Not surprisingly, then, it is with the question of understanding, so central to all the books in the sequence, that this first one begins. To read from the Holy Writings is not the same as reading the many thousands of pages that a person sees in a lifetime, and the unit, "Understanding the Bahá'í Writings", seeks to foster the habit of reading passages from the Sacred Text every day and meditating on their meaning, a habit that will greatly aid participants as they embark on the path of service. To guide them in its study, the tutor must give a great deal of thought to the subject of understanding.

The Bahá'í Writings contain profound spiritual truths, and even as we strive to advance in our understanding of their infinite meaning, we know that we can never reach a definitive end. We generally gain a basic comprehension of the immediate meaning of a passage when reading it for the first time, and Section 1 of the unit takes this as a starting point. Thus, after reading the quotation, "The betterment of the world can be accomplished through pure and goodly deeds, through commendable and seemly conduct", participants are simply asked, "How can the betterment of the world be accomplished?" At a glance, most of the questions and exercises of this kind appear to be too simple. But years of experience seem to justify the Institute's decision to begin this way. We all need to be reminded that, in its haste to find the layers of truth in a passage, the mind should not overlook its obvious meaning. Attention to this first level of comprehension also proves vital to group consultation; it strengthens unity of thought, readily attainable when personal opinions are allowed to be illumined by Divine wisdom.

It is important to note here that understanding the immediate meaning of most passages does not benefit from a long discussion of single words out of context. That said, it may be necessary, on occasion, for a group to look up a word in the dictionary. What may be more fruitful, however, is for the participants to learn how to infer the meanings of words from whole sentences and paragraphs.

For understanding to expand beyond the realm of immediate meaning, examples that show how ideas find concrete expression can be helpful. All that is called for in this respect are straightforward exercises. In Section 2, for instance, participants are asked to determine, in light of a passage they have just read, whether certain characteristics are commendable. In a similar exercise in Section 4, they are encouraged to name five virtues and then decide whether it is possible to acquire any of them in the absence of truthfulness—described in the Writings as "the foundation of all human virtues".

To achieve its purpose, the unit demands a further advance in understanding by challenging participants to think about some of the implications of the passages presented. In Section 2, they are required to determine whether the statement "There are so few good people in the world that their actions do not have any effect" is true. Here the intent is not to elicit mere opinion. The tutor must pause and query the reason for the participants' answers. That the statement must necessarily be false because it contradicts the first quotation in the preceding section is the conclusion to which the group should come. The question of whether Bahá'ís may confess their sins to others is also an example of this kind of exercise. It refers to the prohibition in the teachings against confession as a means of absolving sin, which, not



mentioned expressly in any of the passages studied, can be drawn out by exploring the meaning of the verse, “Bring thyself to account each day ere thou art summoned to a reckoning.”

By no means do the exercises in the unit attempt to encompass the range of meaning enshrined in the passages under consideration. One question every tutor must contemplate is how much discussion should go into any given exercise. Here it is important to bear in mind that prolonging deliberations by introducing many related but peripheral concepts tends to diminish the effectiveness of the material. Every group needs to establish a reasonable rhythm of progress; participants should feel a distinct sense that they are advancing steadily according to their own possibilities. The tutor must, however, stay attentive, lest sections are passed over quickly and superficially without the thoughtful analysis of exercises; groups that have proceeded in this way, merely filling in answers, have never attained lasting results.

One final point deserves some mention: It falls on the tutor to ensure that every member of the group remains engaged in the process of learning fostered by the material. To elicit participation without pressuring any individual to speak is often the challenge. What should be realized from the start is that this challenge is seldom met by asking questions such as, “What does this mean to you?” Questions of this kind tend to reduce knowledge and truth to the level of opinion. And it then proves difficult to create an atmosphere in which consultation among the members of the group actually gives rise to increased understanding.

The second unit in the book is concerned, like the first, with a habit essential to spiritual life: praying regularly. It makes explicit in the opening section the concept of “path of service”, suggesting that, to walk this path, we must be imbued with a twofold purpose. Participants examine an initial set of quotations that offer insight into the nature of this purpose, a theme that will be elaborated in future courses.

Against the backdrop of this theme the unit takes up its exploration of the significance of prayer. It adopts an approach similar to the one described in the preceding paragraphs. Questions and exercises are formulated so as to advance understanding of the meaning of passages from the Writings being studied. As the group progresses through the unit, the tutor may be required to dissipate doubts by analyzing notions rooted in interpretations and practices of the past. In some traditions, ritual and form have gradually overshadowed the importance of inner state, and so many ignore the necessity of prayer, which, for the human soul, is no less crucial than is food in nourishing the body.

Above all, then, the unit aspires to awaken in participants the desire to “converse with God” and to draw near to Him. Among the ideas addressed are what it means to enter into a state of prayer, the posture of our hearts and minds when we do so, and the conditions that should be created in our surroundings, whether we are alone or in a gathering. Indeed, after giving some thought to the forces generated through communal worship, participants are asked to consider hosting a gathering for prayer and devotions.

The study of the third unit of the book, “Life and Death”, will strengthen, it is hoped, commitment to walking the path of service and endow it with more profound meaning. Service in this world is best understood in the fullest context of life, which extends beyond our earthly existence and continues forever as our souls progress throughout the worlds of God. In a process of education, as opposed to technical training, participants should become increasingly conscious of the meaning and significance of what they are doing. Only if such consciousness grows, experience indicates, will they come to see themselves as active, responsible “owners” of their own learning.

Each section of the unit opens with one to three quotations from the Bahá'í Writings, followed by a few exercises. The language of the passages quoted in this unit is more demanding than in the previous two. There is no need, of course, for the group to dwell on difficult words; the tutor will want to ensure that everyone grasps the central idea addressed in each section, which is precisely what the exercises try to bring out.

Given the nature of the subject, exercises involving concrete examples are few and far between. Most tend to operate at a conceptual level. What should be noted is that some of the questions posed by the exercises cannot be answered quickly or in a clear-cut way. They are introduced to raise awareness about the subject; if participants merely think about such questions, the objective of learning will have been fulfilled.

The first several sections focus on the relationship between the soul and the body, which, together, constitute the human being in this plane of existence. The central idea presented in these sections is that the soul is not a physical entity; its association with the body can be likened to the light that appears in a mirror. Neither the dust covering its surface nor the eventual destruction of the mirror can affect the splendor of the light itself. Death is just a change of condition, when the association between the body and soul is broken; afterwards, the soul progresses eternally towards its Creator.

The unit turns next to the question of the purpose of life—to know God and to attain His presence. Discussion here revolves around two broad themes. The first is the purpose of our lives in this world, and the second the journey of the soul after death. The soul is a sign of God and can reflect all of His names and attributes. Yet the potential within the human being is latent; it can only be developed with the help of the Manifestations of God, those sanctified Beings Who come from time to time to guide humanity. Through the spiritual education They provide, the treasures hidden within us can be revealed.

As for the journey of the soul after death, a series of ideas are laid out for participants to contemplate: that those faithful to God will attain unto true happiness; that none of us can ever know our own end and, therefore, we should forgive one another and not feel superior to others; that in the next world, as in this one, the soul will continue to progress and the spiritual faculties we developed here will aid and assist us there; that we will recognize our loved ones in the realms beyond, will remember our lives in this world, and will enjoy companionship with holy and sanctified souls.

The unit comes to a close with a passage from the Writings of Bahá'u'lláh in which we are assured of the benefits of the next world and urged not to allow the changes and chances of this life to bring us sorrow. Participants are asked to reflect, then, on the implications of what they have studied for their own lives.

- \_\_\_ It is not wrong for a married couple to talk about other people's faults since they should not keep secrets from each other.

## SECTION 9

The purpose of this unit, as mentioned at the beginning, is to assist participants in their efforts to develop and strengthen the habit of reading passages from the Holy Writings every day and reflecting on their meaning. To read the verses of God every morning and evening is a teaching of Bahá'u'lláh conducive to our spiritual development. The following passage reminds us of the bounties we receive from fulfilling this obligation, and you are encouraged to commit it to memory:

**“Immerse yourselves in the ocean of My words, that ye may unravel its secrets, and discover all the pearls of wisdom that lie hid in its depths.”<sup>20</sup>**

Having completed this unit, you may wish to acquire a book of Bahá'u'lláh's Writings and read from it every day. The Hidden Words is a good first choice.

# Prayer

## Purpose

To reflect on the significance of prayer and  
to reinforce the habit of praying regularly





## SECTION 1

The courses of the Ruhi Institute are intended to help participants walk a path of service. We walk this path impelled by a twofold sense of purpose—to grow spiritually and intellectually and to contribute to the transformation of society. These two aspects of our purpose are inseparable from each other. Bahá'u'lláh exhorts us in one passage:

**“Do not busy yourselves in your own concerns; let your thoughts be fixed upon that which will rehabilitate the fortunes of mankind and sanctify the hearts and souls of men.”<sup>1</sup>**

In another passage, He makes clear:

**“ . . . the purpose for which mortal men have, from utter nothingness, stepped into the realm of being, is that they may work for the betterment of the world and live together in concord and harmony.”<sup>2</sup>**

In relation to our inner condition, He declares:

**“A pure heart is as a mirror; cleanse it with the burnish of love and severance from all save God, that the true sun may shine therein and the eternal morning dawn.”<sup>3</sup>**

And ‘Abdu’l-Bahá tells us:

**“Your hearts must be pure and your intentions sincere in order that you may become recipients of the divine bestowals.”<sup>4</sup>**

A conviction central to our twofold purpose is that we have all been created noble. Bahá'u'lláh says:

**“O Son of Spirit! I created thee rich, why dost thou bring thyself down to poverty? Noble I made thee, wherewith dost thou abase thyself? Out of the essence of knowledge I gave thee being, why seekest thou enlightenment from anyone beside Me? Out of the clay of love I molded thee, how dost thou busy thyself with another? Turn thy sight unto thyself, that thou mayest find Me standing within thee, mighty, powerful and self-subsisting.”<sup>5</sup>**

To be true to the nobility of our souls, we must turn to the Source of our being and seek enlightenment from Him. One of the most compelling ways to achieve this is through prayer. Shoghi Effendi, Guardian of the Faith, tells us that its chief goal is “the development of the individual and society, through the acquisition of spiritual virtues and powers. It is the soul of man that has first to be fed. And this spiritual nourishment prayer can best provide.”<sup>6</sup>

### SECTION 3

God is the All-Knowing, the All-Wise. He created us and knows what is in our hearts and what is best for us. He does not need our prayers. Then why do we pray?

‘Abdu’l-Bahá states:

**“In the highest prayer, men pray only for the love of God, not because they fear Him or hell, or hope for bounty or heaven. . . . When a man falls in love with a human being, it is impossible for him to keep from mentioning the name of his beloved. How much more difficult is it to keep from mentioning the Name of God when one has come to love Him. . . . The spiritual man finds no delight in anything save in commemoration of God.”<sup>7</sup>**

And, in response to a query, He explains:

**“If one friend loves another, is it not natural that he should wish to say so? Though he knows that that friend is aware of his love, does he still not wish to tell him of it? . . . It is true that God knows the wishes of all hearts; but the impulse to pray is a natural one, springing from man’s love to God.”<sup>8</sup>**

## SECTION 8

‘Abdu’l-Bahá states:

**“It behooveth the servant to pray to and seek assistance from God, and to supplicate and implore His aid. Such becometh the rank of servitude, and the Lord will decree whatsoever He desireth, in accordance with His consummate wisdom.”<sup>15</sup>**

And He explains:

**“Spirit has influence; prayer has spiritual effect. Therefore, we pray, ‘O God! Heal this sick one!’ Perchance God will answer. Does it matter who prays? God will answer the prayer of every servant if that prayer is urgent. His mercy is vast, illimitable. He answers the prayers of all His servants. He answers the prayer of this plant. The plant prays potentially, ‘O God! Send me rain!’ God answers the prayer, and the plant grows. God will answer anyone.”<sup>16</sup>**

It is natural that in our prayers we would ask God to fulfill our needs. Thus we pray for our health and the health of our loved ones, we pray for the spiritual and material progress of our families, and we pray for guidance. We ask for strength, for faith, and for confirmation in the path of service. In praying to God, we should, of course, remember that our goal in life is to align our will with His Will. Therefore, we must pray for His Will to be done and be ready to submit to it. If you commit the following words of ‘Abdu’l-Bahá to memory, they will serve as a source of joy and assurance to you at all times:

**“O thou who art turning thy face towards God! Close thine eyes to all things else, and open them to the realm of the All-Glorious. Ask whatsoever thou wishest of Him alone; seek whatsoever thou seekest from Him alone. With a look He granteth a hundred thousand hopes, with a glance He healeth a hundred thousand incurable ills, with a nod He layeth balm on every wound, with a glimpse He freeth the hearts from the shackles of grief. He doeth as He doeth, and what recourse have we? He carrieth out His Will, He ordaineth what He pleaseth. Then better for thee to bow down thy head in submission, and put thy trust in the All-Merciful Lord.”<sup>17</sup>**

## SECTION 9

From everything we have studied up to now, it is clear that turning to God in prayer is a vital requirement of a spiritual life. How especially sweet it is to pray to God soon after waking in the morning and at night before going to sleep. The time we spend praying each day and the number of prayers we say depend on our needs and our spiritual thirst. On every occasion, we are able to choose from the many prayers revealed by Bahá’u’lláh, the Báb, and ‘Abdu’l-Bahá. Bahá’u’lláh has also revealed, however, three daily obligatory prayers. Shoghi Effendi says:

**“The daily obligatory prayers are three in number. The shortest one consists of a single verse which has to be recited once every twenty-four hours at midday. The medium, which begins with the words, ‘The Lord is witness that there is none other God but He,’ has to be recited three times a day, in the morning, at noon and in the evening. This prayer is accompanied by certain physical acts and gestures. The long prayer, which is the most elaborate of the three, has to be recited only once in every twenty-four hours, and at any time one feels inclined to do so.**

**“The believer is entirely free to choose any one of these three prayers, but is under the obligation of reciting one of them, and in accordance with any specific directions with which it may be accompanied.”<sup>18</sup>**

And he continues:

**“These daily obligatory prayers, together with a few other specific ones, such as the Healing Prayer, the Tablet of Ahmad, have been invested by Bahá’u’lláh with a special potency and significance, and should therefore be accepted as such and be recited by the believers with unquestioning faith and confidence, that through them they may enter into a much closer communion with God, and identify themselves more fully with His laws and precepts.”<sup>19</sup>**

The three obligatory prayers revealed by Bahá'u'lláh are said individually. The kind of congregational prayer where a daily obligatory prayer is recited in a group according to a certain ritual does not exist in the Bahá'í Faith. The Prayer for the Dead is the only congregational prayer prescribed by Bahá'í law. It is to be recited before interment by one of those present, while the remainder of the group stands in silence.

## SECTION 10

We should remember that, in addition to the blessings we receive from obeying the law of obligatory prayer and the nourishment we obtain from saying other prayers individually, our souls are uplifted when we hear prayers being recited in gatherings, large or small. Bahá'u'lláh tells us:



**“Gather ye together with the utmost joy and fellowship and recite the verses revealed by the merciful Lord. By so doing the doors of true knowledge will be opened to your inner beings, and ye will then feel your souls endowed with steadfastness and your hearts filled with radiant joy.”<sup>21</sup>**

We all derive great joy from the knowledge that, around the world, devotional gatherings in which friends and neighbors come together to commune with God are multiplying by the thousands. The Universal House of Justice writes:

**“Devotional meetings are occasions where any soul may enter, inhale the heavenly fragrances, experience the sweetness of prayer, meditate upon the Creative Word, be transported on the wings of the spirit, and commune with the one Beloved. Feelings of fellowship and common cause are generated, particularly in the spiritually heightened conversations that naturally occur at such times and through which the ‘city of the human heart’ may be opened.”<sup>22</sup>**

When we feel moved to pray, we wait quietly for a moment in order to cleanse our minds of the things of this world. While praying, we keep our thoughts centered on God. After we have recited prayers, we remain silent for some time and do not move abruptly into another activity. The same is true when we listen to prayers offered by others in a gathering. On such occasions, we maintain a prayerful attitude and follow the words closely, as though we were the one reciting them.

## SECTION 11

The first unit of this book focused on the habit of reading passages from the Writings every day and pondering their meaning. You have reflected here on the significance of prayer and have, as a result, reinforced the habit of praying daily. The previous section brought to your attention the importance of community worship. All that you have studied so far has prepared you to undertake, if you wish, a first act on the path of service: hosting a devotional meeting.

As an initial step, you may want to memorize several prayers and find an opportunity to share them with a few friends. At the same time, you could ensure that you attend at least one devotional meeting in your community and are counted among its enthusiastic supporters. Eventually, then, you may decide to host a devotional meeting yourself, inviting your friends, family members, and neighbors to gather regularly for prayer and fellowship. It is not uncommon for two or three participants of this course to start such a devotional meeting together.

As you can imagine, there are no formulas for how a devotional meeting is to be organized. But it is clearly a gathering of friends in which prayers are offered, passages from the Writings are read, and uplifting conversations take place—all in a markedly spiritual atmosphere. # Life and Death

## Purpose

To appreciate that life does not consist merely  
of the changes and chances of this world  
but finds its true significance in  
the development of the soul

The human soul is exalted above matter and the physical world. In one of His talks, ‘Abdu’l-Bahá explains:

**“These material bodies are composed of atoms; when these atoms begin to separate decomposition sets in, then comes what we call death. . . .**

**“With the soul it is different. The soul is not a combination of elements, it is not composed of many atoms, it is of one indivisible substance and therefore eternal. It is entirely out of the order of the physical creation; it is immortal!”<sup>1</sup>**

## SECTION 2

A letter written on behalf of the Guardian states that “the soul of man comes into being at conception”.<sup>2</sup> Responding to a question about the meaning of “conception”, the Universal House of Justice notes:

**“Nothing from the Bahá’í Writings has been found that precisely defines the biological moment and nature of the event described as ‘conception’. The use of the term in a medical context also appears to be imprecise. Indeed, one understanding of conception is that it coincides with fertilization; yet another is that it occurs following fertilization and implantation, the onset of pregnancy. Thus, it may not be possible to know when the association of the soul with the material form occurs, and such questions may be insoluble by human thought or investigation since they relate to mysteries of the spiritual world and the nature of the soul itself.”<sup>3</sup>**

## SECTION 3

The connection between the soul and the body is not material; the soul does not enter or leave the body and does not occupy physical space. Its association with the body is similar to that of a light with a mirror which reflects it. The light appearing in the mirror is not inside it. Similarly, the soul is not inside the body. As ‘Abdu’l-Bahá indicates,

**“the rational soul, or the human spirit, does not subsist through this body by inherence—that is to say, it does not enter it; for inherence and entrance are characteristics of bodies, and the rational soul is sanctified above this. It never entered this body to begin with, that it should require, upon leaving it, some other abode. No, the connection of the spirit with the body is even as the connection of this lamp with a mirror. If the mirror is polished and perfected, the light of the lamp appears therein, and if the mirror is broken or covered with dust, the light remains concealed.”<sup>4</sup>**

## SECTION 4

There is a very special relationship between the soul and the body, which together form a human being. This relationship lasts the span of a mortal life only. When the association between them ceases, each one returns to its origin—the body to the world of dust and the soul to the spiritual worlds of God, where it continues to progress. ‘Abdu’l-Bahá states:

**“The human spirit has a beginning but no end: It endures forever.”<sup>5</sup>**

In one of His talks, He clarifies:

**“The spirit does not need a body, but the body needs spirit, or it cannot live. The soul can live without a body, but the body without a soul dies.”<sup>6</sup>**

And the Guardian explains:

**“With regard to the soul of man: According to the Bahá’í Teachings the human soul starts with the formation of the human embryo, and continues to develop and pass through endless stages of existence after its separation from the body. Its progress is thus infinite.”<sup>7</sup>**

## SECTION 5

We have seen that the soul does not occupy physical space and does not operate according to the laws of nature, as do material entities. The soul exerts influence in the world through the agency of the body, but this is not the only means through which the soul exercises its power. Bahá'u'lláh declares:

**“Verily I say, the human soul is exalted above all egress and regress. It is still, and yet it soareth; it moveth, and yet it is still.”<sup>8</sup>**

And ‘Abdu’l-Bahá tells us:

**“Know that the influence and perception of the human spirit is of two kinds; that is, the human spirit has two modes of operation and understanding. One mode is through the mediation of bodily instruments and organs. Thus it sees with the eye, hears with the ear, speaks with the tongue. . . .**

**“The other mode of the spirit’s influence and action is without these bodily instruments and organs.”<sup>9</sup>**

## SECTION 6
