



2024 Terms & Conditions

These terms and conditions apply to the provision of an Indoor, Outdoor or Hot Food stall pitch at Davidson's Mains Christmas Market to the exclusion of any other terms presented by the stall holder. By agreeing to have a stall at the market, these terms will be deemed to have been accepted.

The Davidsons Mains Christmas Market will take place on Saturday 30th November 2024 between 12pm – 6pm. Stallholders can access their stalls from 10am on Saturday 30th November. The Church car park and East Barnton Gardens will be closed to general vehicles from 8am. Stallholder drop off in this area will be allowed between 10am – 11am and vehicle movements will be controlled by event marshals during this time. Trading will cease no later than 6pm and all stock, equipment to be cleared as soon as possible after this time to allow for derigging of shelters.

Please be prepared to drop off stock and move your vehicle out of the area quickly. Longer term parking is available at the rear of Tesco car park.

Outdoor Pitches are priced at £40, stallholders retain all income from their sales made on the day. Pitches are provided with a shelter or gazebo (approx. 3m x 3m) and a table (1.8m x 0.75m). There is no electricity available for outdoor stall pitches.

Indoor Pitches are priced at £50, stallholders retain all income from their sales made on the day. Pitches are provided with a wooden table (1.5m x 0.75m) and access to an electricity point.

Hot Food Pitches are priced at £75, stallholders retain all income from their sales made on the day. Pitches are provided with a shelter or gazebo and a table (1.8m x 0.75m). There is no electricity available for Hot Food Pitches.

Stallholders are responsible for their own area and must ensure the area between stalls is not cluttered / no trip hazards etc. Stallholders are responsible for disposing of their own rubbish at the end of the event. Stallholders may decorate /attach goods to these pieces of equipment, however, they must be returned in exactly the condition they were given in. Do not attach anything in a way that could damage the fabric of the shelter / table.

Stallholders agree to follow all applicable trading laws and regulations including the Sale of Goods Act 1979, Health and Safety at Work Act 1974 and if applicable all food safety legislation including those related to food hygiene.

Stallholders must have all relevant traders' licences, electrical PAT certificates for any electrical equipment, gas certificates if using LPG equipment, health and safety certificates, food trading licences and food hygiene certificates available on request and for display on the day.



Please consult the standards and minimum procedures from the City of Edinburgh Council with regard to 'mobile food units' and any stalls serving open or hot food. Stallholders in this category must adhere to these minimum standards and should discuss with the market team in advance of the event if they foresee any issues with compliance.

The sale of counterfeit, dangerous goods, fireworks and vaping products is strictly forbidden. No glass containers should be used on site.

The Christmas Lights group holds a market operators licence and appropriate public liability insurance for the event. Stallholders agree to hold, if required, a copy of public liability insurance sufficient for any potential liability from your stall.
