What Is the Fifth Amendment?

The Fifth Amendment to the U.S. Constitution protects you from being forced to incriminate yourself. It guarantees your right to remain silent, ensures due process of law, protects against double jeopardy (being tried twice for the same crime), and prevents the government from taking your property without fair compensation. Miranda Rights - What Police Must Tell You

 **Miranda Rights: “You have the right to remain silent. Anything you say can and will be used against you in a court of law. You have the right to an attorney. If you cannot afford an attorney, one will be provided for you. Do you understand the rights I have just read to you? With these rights in mind, do you wish to speak to me?”**

When you're taken into custody, police are required to inform you of your rights—this is called a Miranda warning. But just because you weren't read your rights doesn't automatically mean your case gets thrown out.
