All weekly payments received after Wednesday will be charged a \$20 late fee. All monthly payments received after the 5th day of the month will be charged \$65. Late fees are cumulative; additional late fees will be added weekly or monthly for accounts with outstanding balances.

Additional Information

What is the Activity Fee?

This mandatory fee covers the cost of the Wi-fi, tablets, Chromebooks, and electives. The fee allows students to enjoy arts & crafts, the student garden, prizes, events and special assemblies. Some of the student's favorite events include the Fall Festival, Thanksgiving lunch, Christmas activities, International Week, Valentines Day cookie decorating, Easter egg hunt, and more.

Field trips are not included in the Student Activity Fee.

Tuition Breakdown

Weekly and monthly payments are accepted for your convenience only. You are paying an ANNUAL TUITION FEE. There are no daily, weekly, or monthly fees. The annual tuition can be paid in (10) equal payments due by the 15th of each month or (40) equal payments due at the beginning of each week (including all daycare and holiday weeks). Your tuition covers the (42) weeks during the academic year only.

The (10) weeks of daycare and summer school (mid-June to mid-August) are not included in the annual tuition.

New Student Testing

Your child will join their intended class from the beginning of class to lunch where the teacher will assess their readiness for class behaviorally and academically.

We do not accept students with severe academic or disciplinary problems.

Academic- Our academic program is very traditional. Students must be cooperative, able to follow verbal teacher direction, do seatwork on their own, work in small groups, and complete a substantial amount of work daily. Although our program is effective for most students, some students may not benefit from our program.

We reserve the right to dismiss students at any time if we feel that they are not benefiting from our academic program.

Discipline- Our discipline program is based on the principles taught in the Lee Cantor book, Assertive Discipline. Our goal is to provide a safe and nurturing environment suitable for learning. Every new student will be accepted on a probationary basis. In order to maintain a suitable learning environment for ALL students, students with severe discipline problems may be expelled at any time at the discretion of the administration.

PARENT'S/GUARDIAN'S FINANCIAL OBLIGATION

As a parent or guardian, it is essential to monitor the charges on your account in Brightwheel and ensure that payments are made on time. Please note that fees, such as those for tutoring or field trips, have different due dates and may incur late fees or result in the cessation of activities if not paid on time.

If your account becomes delinquent during the school year, a block may be placed on your student account, affecting future registration. Consistent late payments may lead to your child being unenrolled from the program.

NON-PAYMENT AND OVERDUE ACCOUNTS

If a parent or guardian fails to meet their financial obligations to the school, specifically if they have unpaid fees totaling \$500 or more and are consistently 21 or more days overdue, the school board grants the administrative staff the authority to revoke the student's active status on the roster, which will suspend the student's attendance.

Additionally, the school may withhold the student's report card and/or diploma until the financial obligation is met.

The accounts department has the authority to unenroll the student until the account is current.
