LEASES

The Center utilizes three offices located at: San Bernardino, Indio, Coachella, and, Palm Springs, California. Facility rent is estimated based on the lease agreements provided by management. Per the terms of the Indio lease, this location utilizes 3,675 square feet with a base rental payment of \$4,817.57 per month (\$57,811 annually) plus common area maintenance equal to 18.09% of the total which are estimated at \$1,331.15 per month (\$15,974 annually). As a result, the total annual facility rent at Indio is \$73,785. Per the terms of the Coachella lease, this location utilizes 1,000 square feet with a base rental payment of \$1,300 per month (\$15,600 annually) plus common area maintenance equal to 4.59% of the total which is estimated at \$450 per month (\$5,400 annually). As a result, the total annual facility rent at Coachella is \$21,000. However, management has indicated the Coachella location is shared equally with a primary care clinic, Cornerstone Medical Services, Inc. As a result, the total annual facility rent for the Center is \$10,500. Per the terms of the Palm Springs lease, the Center has a base rental payment of \$6,200 per month (\$74,400), but a portion of the space is shared with another physician. As a result, the Center receives a credit of \$1,560.02 per month (\$18,720 annually). Additionally, the Center pays a signage expense of \$60,000 annually beginning in May of 2016. Based on our understanding, the signage expense increases at \$10,000 per year until April 2020. As a result, the total annual facility rent at Palm Springs is \$115,680. Accordingly, the total annual facility rent is approximately \$210,000 in the Normalized Base Year and \$226,000 in Year 1.
