### **FAQ**

What are vaccine anti-discrimination laws?

Vaccine anti-discrimination laws are designed to stop the emersion of a two-class society. For example; some people are eligible for meaningful employment and others are not.

Why are these types of laws needed?

Without vaccine anti-discrimination laws, individuals can be banned from full participation in society simply because they have not received one or all vaccinations. Vaccination mandates promote a one-size-fits-all solution for protecting people from infections. These policies are created with the assumption that everyone can safely receive any vaccine regardless of their health status, and that every vaccination is effective and necessary. We are not all the same, these laws allow equal protection under the law regardless of vaccine status.

Can't someone just ask for an exemption from vaccinations; is a law needed?

Exemptions can be applied subjectively and may not be considered equally for each person. Who decides whether someone is entitled to an exemption can greatly impact one's ability to be granted one. Seeking an exemption requires an individual to take actions that others would not be required to take, and this alone is discriminatory. All individuals should be offered equal rights without having to disclose private health information or justify their beliefs.

Exemptions are not sufficient.

Should we prohibit mandates even though the vaccine decision affects those you work with?

Historically, any individual who received a vaccination was assumed protected against infection if exposed to the illness. Many vaccines do not prevent infection or transmission to others. Any protection afforded is temporary and personal.

### **FAQ (CONTINUED)**

Where does the vaccine anti-discrimination bill apply?
It prohibits discrimination against anyone in the State because of their vaccination status. This includes discriminating by a person, governmental entity, employer, or public accommodation against an individual by requiring proof through an immunity passport.

Does the bill apply to my employer?

Yes. The law prohibits an employer from refusing employment, barring a person from employment, or discriminating in any term, condition, or privilege of employment based on vaccination status or whether the person has an immunity passport.

Can a person, governmental entity, public accommodation, or employer ask about your vaccination status or ask you to produce an immunity passport?

Nothing in the language prohibits a person, governmental entity, public accommodation, or employer from asking about vaccine status or whether you have an immunity passport. However, if asked, a person is not required to respond and may not be discriminated against for failing to respond.

Should the vaccine anti-discrimination law apply to COVID-19 only or to all vaccines? There will never be a time where a government entity or employer should intervene in an individual's health care decisions. Public health emergencies do not eradicate individual liberty; these liberties are even more important during times of emergency, not less important. All medical products will find their proper place in the market. If there is a devastating disease circulating, but a very effective treatment is available, people will gladly line up to take the treatment or product. But it needs to remain a choice, never a mandate.
