

No Limits Dance Academy Studio Policies

2025-2026

General

- Enrollment is based on an annual basis (September - June Recital). Because continued attendance is essential for maintaining class progression and is necessary for improving and maintaining each dancer's technique, "taking time off of classes" is not permitted without prior approval and in extenuating circumstances only.
- Parent observation of classes is limited to the LAST week of classes each month. In special circumstances, exceptions may be made. One person per dancer is allowed to observe (no siblings, additional relatives, etc.) Parent observation is for observing only. No talking to the dancers, talking on cell phones or talking to other parents is allowed.
- In order to ensure the most professional and beneficial environment for learning dance, all students must wear their hair pulled back securely away from their faces and dress in proper attire as described in the studio dress code. Proper footwear in the correct color must be worn. See the studio dress code for more details.
- Dancers must be 3 years of age prior to enrolling in classes. The expectations for the little dancers are that they are fully potty trained and are able to be in class and listen to the teacher without a parent present. Exceptions may be made at the discretion of the studio director.
- Dancers are placed in levels based on their age and abilities. It is at the discretion of the studio director and the assistant director to place the dancers in the appropriate classes.
- Food is not allowed in the studio. All food related trash must be thrown away in the outside garbage bin. Water is the only beverage allowed in the studios. NO GUM ALLOWED!
- If Halloween (October 31st) falls on a weekday, classes that day will be cancelled.
- The studio will be closed for Labor Day, Thanksgiving break (1 week), Winter break (2-3 weeks depending on the calendar), Presidents break (1 week), Spring break (1 week), Memorial Day.

Tuition

- Tuition is paid based on a yearly rate. Tuition is the same amount each and every month (September - June). There are no refunds for unattended classes or studio vacations.
- No refunds will be given if a student drops a class after the 1st of the month. If a student wishes to drop a class, the parent must notify the studio before the first of the month. If a student drops a class after the first of the month, tuition in full will be due. (For example, if a dancer does not wish to dance in January, we must be notified by December 31st.)
- Tuition can be paid in full by semester or month to month.
- No refunds or credits will be given for tuition payments.
- There is an annual \$20 registration fee for each student (\$15 for students who pre-register).
- Tuition is due the 1st of each month and is considered delinquent after the 10th of the month. Please make your payments in a timely manner. If you need to make special arrangements for tuition payments, please contact us and we will work out the details.

- Any tuition that is paid after the 20th of the month will have a \$20 late fee added to it.
- Only 1 person should be responsible for tuition. If tuition will be coming from multiple sources there must be only 1 person listed as the contact. This is to avoid complications with payments.
- If tuition is two or more months past due, the dancer's parents/guardians will be contacted, and the dancer will not be able to attend class until past due tuition has been paid in full.

Surcharge policy

- In an effort to cover the costs of credit card processing fees, we will charge 2.89% to every transaction paid with a Visa, Mastercard, or Discover credit card.
- This surcharge will not be applied if you pay with cash or check payments.
- We will NOT be accepting debit cards, AMEX or ACH/bank drafts.

Attendance

- If your dancer is going to miss 2 or more classes in a row please let your teacher know ahead of time or email the office. If you don't know ahead of time, please email the office as soon as you do know.
- No make-up classes are allowed for missed class due to illness or student absences. Private lessons may be available at the teacher's convenience at additional cost.
- The studios' flex months are September (fall semester) and January (spring semester). These are the months that we can accept and enroll new/waitlisted dancers if a dancer drops a class. We feel this is also enough time for a dancer to decide if they want to stay in class and perform in the shows. Past these flex months, your dancer's spot is secured and full tuition is expected to be paid throughout the remainder of the semester. Dropping during these months can cause hardship to their fellow classmates, the teacher and the studio.

December show

- All students will have the opportunity to perform in Candy Cane Lane, the studio's December recital (provided certain conditions have been met).
- Good class attendance is required to be in the show.
- All tuition, costume and studio fees must be paid before the show.
- Participation in the dress rehearsal is mandatory for dancers to be in the show. A dancer that does not participate in the dress rehearsal will not be allowed to participate in the show.
- Due to facility costs, there will be an admission charge to all those attending the recital (with the exception of the dancers).
- Most costumes for Candy Cane Lane will be provided for the dancers at a minimal rental fee.
- Older/more advanced dancers may have to purchase their own costumes.
- All studio families must follow the studio's show rules and policies which includes but is not limited to: being kind and respectful to the studios show staff/volunteers and following

instructions. Families that choose to go against the studio show policies may be asked not to come back to the studio.

June Show

- All students will have the opportunity to perform in the studio's June recital(provided certain conditions have been met).
- Good class attendance is required to be in the show.
- All tuition, costume and studio fees must be paid before the show.
- Participation in the dress rehearsal is mandatory for dancers to be in the show. A dancer that does not participate in the dress rehearsal will not be allowed to participate in the show.
- Each dancer will be required to pay a \$10-\$20 production/trophy fee for the June show. This will be collected in May or June.
- The cost for most June recital costumes ranges from \$60.00 - \$80.00 per costume. More advanced classes may be higher.
- Costumes must be paid for before they are ordered. If June recital costume payments are not turned in on time, the costume will not be ordered and the dancer will not be allowed to perform in the show. June recital costume payments will be due in January/February. This ensures enough time to order costumes to arrive in time for the show. There are no refunds on costumes.
- Due to facility costs, there will be an admission charge to all those attending the recital (with the exception of the dancers).
- All studio families must follow the studio's show rules and policies which includes but is not limited to: being kind and respectful to the studios show staff/volunteers and following instructions. Families that choose to go against the studio show policies may be asked not to come back to the studio.
