# Legal Update

The legal committee met with the lawyer and agreed to start with sending out letters regarding chickens, excess cars and clean up/nuisance. We will be looking into members that aren't paying assessments and pursing contracts for rent to own.

### **Boat Stickers for 2019**

We have ordered the boat stickers for 2019 and they should be here by the first of December if not earlier. Any type of water craft must have a sticker to be on the lake. You must have your 2019 assessment paid in order to purchase a 2019 boat sticker for \$10.



### Assessments for 2019

Assessment billing notices for the 2019 year are being mailed. The assessments are for the membership year January 1, 2019 through December 31, 2019. Just a reminder the Assessment on the 1st lot was raised to \$130, additional lots will remain at \$50. The Special Assessments are now \$25 per lot. Commercial assessment has been increased to \$400 per year. Also, the early discount has been removed. We do not accept credit cards, but you can have your credit card company issue a check to us if you wish to pursue that route.

## **Payment Plans**

If you would like to pay the assessments in installments, you can set up a payment plan. As long as you make your monthly payments, you will be considered a member in good standing. If you set up the payment plan to be completed by May 31, 2019, you will be able to vote for board directors. Otherwise payments need to be completed no longer than December 31. If you owe back due assessment, you have the option of signing a covenant to have them forgiven and only owe the current year assessment. You can also sign a payment plan, but have to work with office to figure out a plan of action to get the back assessments paid off.

### Beach

The swim dock and ropes have been removed. The restrooms have been winterized and are now locked. Work will begin this winter to repair the swim dock.

### Changes
