GENERAL RECOMMENDATIONS

AERIAL/CONCENTRATE APPLICATIONS: Apply 1 to 3 quarts in minimum of 5 gallons water. The addition of a non-ionic surfactant will improve coverage.

IRRIGATION/SOIL: (Boom, Drip, Pivot, & Sprinkler) Apply 1 to 4 quarts per acre.

Maximum seasonal rate is 4 gallons per acre.
FOLIAR APPLICATIONS AND RATES

FIELD & ROW CROPS: Apply 1 to 2 quarts per acre 2 days after transplant and repeat every 14 days as necessary to increase production and quality.

FRUIT, NUT, & VINE CROPS (Including Citrus & Tropical Fruits: Apply 2 to 4 quarts per acre per application in sufficient water for coverage. Repeat applications as needed in accordance to crop requirements. Young Trees: Apply 2 to 4 quarts per acre in sufficient water for thorough coverage. Repeat applications on a regular basis to maximize growth.

ORNAMENTALS, NURSERY, & GREENHOUSE: Apply 1 to 2 quarts per 100 gallons of water weekly or as needed.

TURFGRASS & SOD (Warm & Cool Season): Apply 3 to 6 ounces per 1000 sq. feet as needed for maintenance. For deficiencies apply 8 to 12 ounces per 1000 sq. feet. Applications can be made every 7 to 14 days as needed for desired results. VEGETABLES & COLE CROPS: Apply 1 to 2 quarts per acre in a minimum of 50 Gal. of water Apply first application 2 days after transplant and repeat every 7 to 14 days as needed to increase production and quality.
