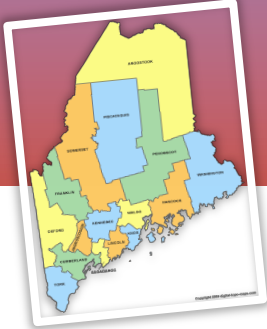

Where is SoS, Shenna Bellows???

“What does the Secretary of State do?”

In Maine, the Secretary of State oversees one cohesive Department made up of three distinct bureaus: the Maine State Archives, the Bureau of Corporations, Elections and Commissions (CEC), and the Bureau of Motor Vehicles (BMV). The Secretary of State's responsibilities include serving as the state's Chief Elections Officer, implementing electronic filing and internet disclosure of campaign, lobbyist financial information, and Maintaining business filings.”

Dr. Douglas Frank returned to Maine October 30- November 3, 2023. On October 31, Dr. Frank, John and I went to Augusta to try to meet with Shenna Bellows. We were told she was in a budget meeting and could not come out of the meeting because you know budget meetings are so important. We were able to meet with Dorothy “Dottie” A. Canelli, Deputy Secretary of State, is how she introduced herself. She asked why we wanted to meet with Shenna. Marlene explained that when Shenna came to our town meeting to say she thought it was illegal to not have the voting machines in our town due to handicapped people needing the machine for handicapped people. When I explained that the machines do connect to the internet. She said the machines NEVER connect to the internet and if I have proof to bring the proof to her, so that is why we are here. I pointed to Dr. Frank and said, here is

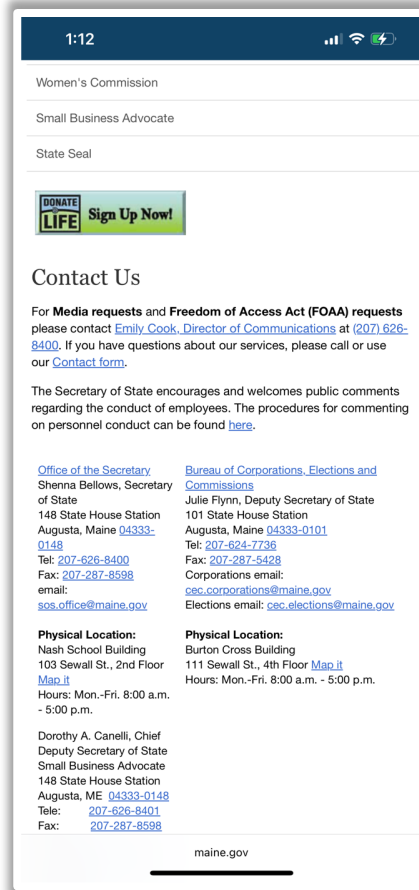

my proof. Dr. Frank explained how the voting machines were on a secure network; like Bank of America's secure network, which was hacked. He explained we only needed about 5-10 minutes with Shenna to have her give his friend permission to hack into the voting machines. Shenna would have to be present for him to have his friend do it and they would give her the passwords to her system. Dottie went upstairs to find out if Shenna would be able to come down. Dottie returned without Shenna and said this is a very important budget meeting. I said our elections are extremely important. Dr. Frank asked if we wait would she give us 10-15 minutes after the budget meeting? Dottie said no, they do not know when the meeting would end. Dr. Frank stated since Shenna took 5 ½ hours to go to Sullivan, stay at the town meeting and traveled back to Augusta to state the machine NEVER access the internet, but doesn't have 10-15 minutes for election integrity that proves the machines do have the capabilities to access the internet through Bluetooth. He said she may not even know that ES&S DS200 machines have the capabilities, because she may have ordered them without such capabilities, but ES&S shipped them with the capabilities. We want to work with her and help her. Dottie said you must make an appointment at least a month in advance. I asked, how can you make an appointment because when I tried in June for July when Dr. Frank was going to present and again in August when he was coming back in November, I was passed from one to another and no one would make the appointment? Dottie gave me her phone number to call to set up the appointment. We felt she was trying to be helpful.

I received confirmation for dates for Dr. Frank's return trip to Maine. I called to set up an appointment for February 13 or 14, 2024. Dottie said she would give Mary my contact information and she would get in touch with me. I asked, if I don't

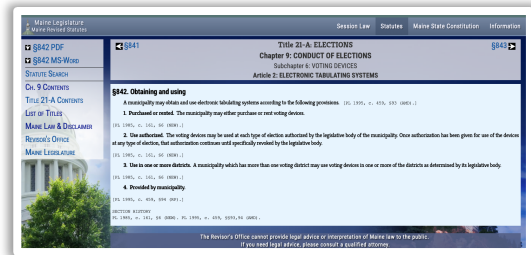

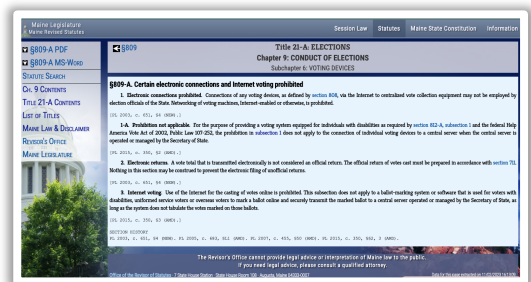

She said she checked the schedule and Shenna was out of the state and would not be able to meet. **Hummm...One of my friends, told me that we are getting new machines for Maine, but didn't know what type.**

1. The Secretary of State for Bureau of Corporations, Elections, and Commissions is Julie Flynn. Dottie is a Deputy Secretary of State but not for Elections.
2. Shenna Bellows stated I did not think it was legal not have the voting machine for people with handicaps. TRUTH: In Maine, municipalities MAY choose to use a voting machine, which means a municipality DO NOT have to use voting machines. Hence, a municipality only needs to have the machine for individuals with handicaps only if they choose to use the voting machine.
3. In Maine according to SoS Shenna Bellows, who took 5 ½ hours out of her day to appear at Sullivan's town meeting to state voting machines NEVER connect to the internet but would not come down a flight of stairs so Dr. Frank could prove that they do. She, also, sent an email stating this.
4. In Maine electronic connection of voting machines is prohibited (see side screen shot).
5. Is Shenna in meetings or at conferences out of state on February 13 or 14, 2023?
6. Was Dottie running interference for Shenna or Julie?

 Internet Connection of Voting Machines*

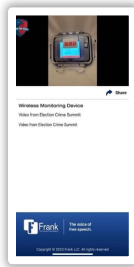


Action, Action, Action
