Board Certified Behavior Analysts:

A **Board Certified Behavior Analyst (BCBA)** is a person who is certified and trained to provide and supervise supports using Applied Behavior Analysis. Behavior Analysts are trained to help determine the function of the behavior and provide behavior intervention strategies based on assessment results. The BCBA can recommend functionally equivalent replacement behaviors for the individual in hopes to decrease their displays of challenging behavior.

New Jersey's Division of Developmental Disabilities (DDD) has BCBA's who:

- 1.) Provide **specialized behavioral trainings** to residential and day program staff.
- 2.) Provide **consultative support** to agency behaviorists that work with individuals with behavioral challenges at home or in the community.

Common Behavior Concerns:



- Aggression
- Self-Injury
- Property Destruction
- PICA
- Walkaway/Elopement

Behavior Trainings:

At no cost to the workshop attendee, the BCBA can provide the lecture to a large or small group of participants; either in-person or remotely.

Behavioral Consultation:

At no cost to the provider or the individual, the BCBA will provide consultative support to behavioral staff at provider agencies with a documented history of behavioral concerns. BCBA staff can also assist with individuals transitioning between residential settings and up to 90 days post placement.



Consultations may include:

- Recommending proactive and/or reactive strategies and behavior interventions.
- Providing training on how to develop an effective behavior support plan or revision of an existing plan.
