Now comes Relator who responds to the City's Trial Brief as follows:

I. Twinsburg's Charter and Laws.

The parties agree that Twinsburg's Charter and Ordinances requires a vote on "any change in zoning classifications or district or in uses permitted in any zoning use classification or district. Charter Section 7A.01. The parties disagree on whether height regulations fall within that description.

This problem is solved by the Code. The purpose of the Code is to "....to regulate and limit the **height**, bulk, number of stories and size of buildings and other structures (Ord. 87-1989. Passed 7-11-89). (Gaydosh Depo., Ex. A.). The last comprehensive revision of the Code was approved by voters in 1989. They voted on **Chapters 1137 through 1161**. Ex. 6. Amendment of those Chapters requires a vote. Height regulations fall within those Chapters.

Twinsburg correctly states it is illogical to vote on tree spacing because tree spacing was not part of Chapters 1137 through 1161. Chapters outside that range do not trigger a vote. Such Chapters regulate home occupations, fencing, signage, parking, and tree placement and can be adjusted by City Council. *Id*.

It is illogical to not vote on changes to height regulations because those regulations were originally voted on by Twinsburg's citizens. A change to the height regulations, like a change to any other Chapter originally voted on, requires another vote.

The City must follow its Charter. The voters reserved to themselves the legislative zoning power in Charter Section 7A.01. What the voters passed, takes the voters to change. Gaydosh simply asks to vote on any changes to height regulations the voters previously adopted. Gaydosh Depo, p. 36.
