Environmental and Social Safeguards Policy of FRD

1. Definitions

2. Policy Statement:

The main purpose of the FRD environmental and social safeguard policy is to address environmental and social issues in the different stages of project planning, designing, implementation, and operations. There are eight (8) key themes of FRD environmental and social safeguards policy Sustainable Natural Resources Management, Ecosystems and Biodiversity, Resource Efficiency and Waste and Pollution Management, Climate Change, Protection and Human rights, Gender Equality, Community Health, Safety and Security and Accountability to Affected Populations. FRD main goal is to improve the socio-economic conditions and empowerment of the vulnerable and marginalized segments of the society through equitable and sustainable utilization of resources.

2.1 Sustainable Natural Resources Management

As an important part of our mission, the FRD Organization is dedicated to the sustainable and ethical management of natural resources. Our commitment to protecting and maintaining the environment while achieving our corporate objectives. The management of natural resources sustainably is essential to ensuring the well-being of current and future generations.

2.2. Ecosystems and Biodiversity

The FRD Organization is committed in its dedication to biodiversity and ecosystem preservation and sustainable management. We understand that healthy ecosystems and rich biodiversity are

3. FRD Policy Framework

FRD project interventions intent to develop and implement mitigation measures to minimized adverse environmental and social impacts. In the environmental safeguarding, FRD has already implemented various projects on promoting nature based solution in climate change adoption (Rain water harvesting techniques like construction of check dams, construction and rehabilitation of rain water ponds, flood protection walls, rehabilitation of springs, water storage ditches, and capacity building trainings. In climate mitigation, FRD has implemented different types of activities that include plantation drives, Integrated Fuel Efficient stoves, capacity building trainings and many others.

On social safeguarding theme, FRD has designed and implemented different types of initiatives for poverty reduction (conditional and unconditional cash transfer programmes, diversification of livelihoods, gender inclusion, promoting social cohesion and peace, provision of temporary livelihood initiatives, community health and safety measures (first aid and behavior change components), restriction to access to resources, community resilience and many others.

Additionally, FRD is also a signatory of Integrated Food Security Classification (IPC), Global Network of Civil Society Organization for Disaster Reduction (GNDR), Environment and Climate
