MS/HS Principal Update (Ms. Guirlando, Mr. Ferrara, Mr. Morelli):

- Implemented model around discipline and restorative practices in school how discipline is managed and detention is given – expanded this year and moved model into the HS (largely successful)
- Brought workshop in restorative practices worked with Middle School and High Sschool
 teachers, counselors and administrators K-12 initiative Ms. Higgins pilot with community
 circles in classrooms and survey kids before and after to understand how they impact the
 students and a sense of community move in a direction of community base and how students
 can learn from their mistakes
 - 3 High School teachers that stepped up and were excited about the initiative and attended a personal development meeting October to review training and what a pilot would look like in the high school
 - High School disciplinary consequences –detention moved from lunch to after schoolkids feel impact to missing sports practices – coaches were made aware and are on board with change, it is nice to have alignment and have everyone on board with managing consequences
 - Detention students write a reflection on how they can improve and then complete non-electronic homework
 - 2nd year in middle school using restorative practices writing reflection goes a long way and allows for a meeting with students on a smaller group to come up with plan moving forward
- Field Testing NJSLA, NJGPA week of October 27th MS and HS practice test used for state to gather data – adaptive test determined by how a student answers each question
- Q: Policy on limiting tests in a given day A: System used in High School to work around work load
 planner in Schoology, see how many assignments are due in a particular day quick shorthand
 for teachers to see what students have on a given day helps to plan assessments, slow start to
 this year and will reinforce to staff. Does not limit number of tests, but is informative and
 encourage students to advocate for themselves
- Q: Finals were brought back what do you do with that data? What are you looking at, are supervisors looking at tests? Stress of students during that week? A: Department meetings are looking at benchmark data, final exam falls into that data. Teachers with a common course plan

benchmark and exams together, provides data on where to tighten up. In terms of stress, Sean Prichard – mindfulness and breathing work with students in different assemblies. Opportunites for students to be in gym and study rooms and have options for students to have access to before or during the exams. Big change – based on student advisory committee, seniors can be exempt from exams. As long as projected final grade is a 90 by June 1st you are exempt as a senior
