- In the first minutes after being elected, named an entire park after their benefactor (with no discussion whatsoever)
- Passed a 3 foot hedge height limitation for all homeowners
- Included possible jail time for violators of their new landscape ordinance
- Defeated a forensic audit vote to follow the unexplained money movements in more than 30 Town bank accounts.
- Refused to change their ordinance forcing homeowners to spend thousands to fix sewer lines on Town property
- > Dragged their feet for two years on the televising of Town meetings until days before this election

- Constructed, without any plan or public input, hugely expensive and functionally deficient traffic circles.
- A kids water park with no, plan, competitive bids, public input or recycling water. It now may need to be removed.

- Decrease our extremely high real property tax rate and eliminate the secret utility tax burden while increasing services through new efficiencies and new technologies at Town Hall.
- Welcome all sides & viewpoints. Instill a customer service & accountability mentality in all departments and staff.
- Increase police presence by reducing administrative burdens on our officers and returning them to their cars to patrol.
- Revitalize and renew our downtown district with preserved facades and other aesthetic improvement incentives.
- Slow down traffic by adding more modern traffic calming devices like those near the Mayor's house on 88th St.
- Institute a design review board, of residents specializing in architecture, in our city to assist residents and businesses with their renovation projects and to insure a continuity and compatibility of designs, colors and features that will protect our Town's diverse and historic culture and atmosphere.
- Streamline the permitting process relieving residents of the necessity to practically hire lawyers to pull permits.
- Institute a comprehensive landscaping plan for the entire Town both in the residential and commercial districts.
