*****NOTIFICATION OF SITE VISITS*****

In accordance with O.C.G.A 48-5-264.1, the Chattahoochee County Board of Assessors must notify property owners prior to making a site visit. The said property visit will be for the purpose of determining the accuracy of the information contained in the county's appraisal record for the property. Reasonable notice is hereby given that a representative of the county appraisal staff will review and physically inspect properties. The staff member should arrive in a clearly marked county vehicle and be prepared to provide identification upon request. Reasons for the site visit include, but are not limited to the following: Sale or purchase of property, new construction, active building permits, a return filed, an appeal filed, application for exemption filed, or a three-year review visit as recommended by the Department of Revenue Appraisal Procedure Manual Rule 560-11-10-.09(2)(d)4(iii). These appraisal reviews will include measuring structures, listing construction information, and photographing the subject property.

I hereby certify to the best of my knowledge and Belief that I have read and examined this document and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. Granting of permit does not presume to give authority to violate or cancel the provisions of any other federal, state or local law regulating construction or the performance of construction.
