Chairman Coffey the Public Hearing of the *Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia* to order at 6:00 p.m., with all other Commissioners present with the exception of Commissioner Hoyte, and live streaming on our Facebook page.

PUBLIC HEARING

CHAIRMAN COFFEY opened the Public Hearing for the Conditional Use Permit for The Lopez Family at 105 Mustang Dr., the property is 1 acre, they would like to replace the existing mobile home with a new mobile home. Oct. 2024, Ms. Lopez has a 1990, with black mold, she would like to replace this mobile home with a new one, the planning and zoning has approved her request. Zoned R1, and 1 acre. A representative from planning and zoning is in the audience, Brent Ingersoll, he is the Chairman.

OPENING REMARKS

Janet Lopez – 105 Mustang Dr, purchased the property because her son lives at the end of the street, and he is in the military. She wants to be able to support her family, they have a teenager and a newborn. They are trying to update the current property and give more value to the land. (7:57 minutes left to speak)

Kitara Wilson – 108 Mustang Ct., for 38 Years, home of record, she has been silent the whole-time things have been going on in her community, but when this CUP came around, she felt her voice be heard, nothing against the family, but she thought the ordinance stated her neighborhood would be stick built homes would be put up and not mobile homes. She stated that the values will start to go down if the mobile homes keep coming in her community, she stated she doesn't know why a better inspection was done prior to buying the property and they would've seen the black mold, and maybe not even made the purchase.

Matt McAdams – (Passed out the county ordinance) 128 Mustang Dr. He stated he does not want to be here again, it causes hurt in his community, the Lopez's live right next to him, they are great people, he just wishes we can stick to the ordinance. Appendix A.3, conditional Uses, deemed appropriate, when certain conditions are met, section 11, page 3, preowned manufactured homes, shall only be permitted in r1 and r3, we've been through this before, the majority is stick built homes. He does not see how it meets the conditions. He doesn't see how it can get this far, or past planning & zoning, and if he is wrong to let him know. He wants to know what is conditional use and how does it benefit the community, he would like to see it go away all together.

Melissa Haymond – 109 Mustang Dr., she stated here we are back again, we walked around again, she stated she is there in opposition of the CUP, those are 3 communities that came as 1. There is one entrance and one exit. She stated the lot is one acre it is suitable for a stick built home, they haven't had any other lots over there in over twenty years that have had a mobile home moved in. People talk about how they love to trick or treat in the neighborhood. She stated all of the other mobile homes were grandfathered in. She walked around with Mrs. Sheila Wilson and most of the neighbors agreed and signed a petition that they didn't want a mobile home in the neighborhood.

Sheila Wilson – 108 Mustang Ct – She would like to welcome the Lopez's to the community, but she is in opposition of the Conditional use permit. She believes there are other options than mobile homes. There have been written promises to her, from George Adams Jr. Here heart & soul is there. She isn't sure about the 5 acre rule for mobile homes, but she thought we had that at one time, and that did secure her area at one time. It is very hard for her to stand and talk about the same thing again. She understands with the CUP you have to advertise, and let your neighbors know. She has people that she has lived by for 30 years, she may not know them, but she knows that she is protected by them.

Janet Lopez – Wanted to thank everyone, and she walked around all summer and said hello to a lot of people, no matter what the decision is, she still enjoys the people around her. She also wanted to thank everyone for their time.

Chairman Coffey asked if there were any questions before they close the hearing, Commissioner Frost stated the process isn't perfect, some adjustments need to be made, the permit isn't just for one neighborhood. it is for the entire county, we have some flexibility, the big picture with the CUP is that it is for the entire county, we do need to go back and visit the conditional use permit and change or tweak the permit. Commissioner Biddle agreed with Commissioner Frost, and he also stated he feels for the people in this neighborhood, and we need to change the conditional use permit. The Attorney stated if there is a desire to change the process, right now they must go through this hearing process no matter what. Chairman Coffey thanked the Lopez's for coming. Just for the record we have 44 signatures against this, we have substandard lots unusable that landowners paid taxes for and that is why we started the CUP process and help the tax base, in doing that a lot of changes took place, the 5-acre rule went away, it now has to go through this process. Not saying we can't change anything. We want people to be able to use their properties. Planning & Zoning can recommend deny, and it will still come before the Commission. The way the law stands, the majority of that neighborhood is stick built. The county is currently being sued for \$5 million, for a decision not going in their favor. This has driven a wedge in our county, neighbor against neighbor. Matt McAdams asked if there could already be a checkbox where it didn't meet certain requirements, like a checkbox and went to planning & zoning could it stop there and not go any further, the Commission said that could be something to consider. Mr. McAdams did have time left to speak. Sheila Wilson (4.5 Minutes) when she was walking and didn't know the Lopez's she was thinking of ways to develop the property like a park, but she also looked into building a home, and she has a builder who can build a home for \$112,000.00, if the Lopez's are interested, she has family suffering from black mold right now elsewhere. Kitara Wilson Bonds – does not want to come back here, what she understands is that landowners benefit from property, she feels these two issues wouldn't be the case if the CUP are actually being used for what they were meant for, where are the conditions. **Melissa Haymond** – What protected everyone was the 5-acre ordinance. The CUP put in by this Board without the vote of the citizens, which is your right, but now everything has to come before you. Chairman Coffey asked if the Lopez's had any further comments, they did not, he asked the Commission if they had any further comments before they closed the public hearing, they had no further comments.

Motion to adjourn the Public Hearing made By **Commissioner Frost**, Seconded by **Commissioner Biddle**. The vote was unanimous.

There being no further business to be conducted by and with the Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia, Chairman Coffey declared the Public Hearing of the Board of Commissioners adjourned at 7:00pm on Tues, Dec. 3, 2024.

Carlos Negron - Speeding on Wells St. - Did not show.

OLD BUSINESS

ATTORNEY - has not met with the Cemetery Committee, still yet to be done. Sent an email with resources on HB 581, since it has passed the bill has changed property tax procedures for homeowners, and it can change to where we have a floating sales tax, or floating tax exemption. Whether they want to opt in or not, you can not opt out until Jan. 1st, if you want to opt out you must have three public hearings and a resolution sent to the secretary of state sent by March 1st, and it is permanent. If you do nothing you are automatically opted in.

County Manager – The County Manager stated HB 581 would be good for our county, and we won't have to do anything to already be in, that himself, Alan Horniday, and Crystal Walker went to a seminar on HB 581 in Macon, to get more information. The only downside was that you cannot increase anyone's residential property value. Board of Elections member pay, there is a pay per meeting of \$25.00, the current Board of Registrars were appointed by the Grand Jury, so those people are who we are appointing to the Board of Elections, there has been confusion with the Board versus poll workers, we do bring on poll workers to work on Election Day, and they receive and hourly wage for working on Election Day. If anyone would like to work as a poll worker, they can come to Lisa and we will get there information.

NEW BUSINESS

ATTORNEY – He has joined a new law firm, called Clark Hill, a larger firm, his hourly rate will increase to \$325.00 an hour starting Jan. 1st. The only reason for an engagement letter is so any files can be transferred. The section in the charter on appointing a county attorney says the attorney shall be appointed by the commission, he doesn't see that there must be a vote every year. However since there is a letter and he has gone to a new firm, he recommends a vote.

County Manager – Nothing that is not on the agenda.

<u>Cemetery By Laws:</u> Motion made to table until next Work Session by **Commissioner Biddle**, seconded by **Commissioner Frost**. The vote was unanimous.

<u>Purchasing a truck for the Sheriff Dept.</u>: Motion made to put on Work Session Commissioner Frost, seconded by Commissioner Biddle. The vote was unanimous. Since SPLOST did pass this can be looked at, however would like to look at a report of all vehicles and mileage, and statuses. Also a response from the sheriff by either email or by phone to the County Manager, by the next meeting.

<u>Appointment of Nancy Hoard to the Board of Elections:</u> Motion to approve by Commissioner Biddle, seconded by Commissioner Douglas. The Vote was unanimous.

<u>Appointment of Valerie Lassiter to the Board of Elections:</u> Motion to approve by **Commissioner Frost**, seconded by **Commissioner Biddle**. The Vote was unanimous.

<u>Appointment of Crystal Walker to the Board of Elections:</u> Motion to approve by <u>Commissioner Frost</u>, seconded by <u>Commissioner Douglas</u>. <u>Commissioner Biddle</u> reclused himself from the vote. The Vote was unanimous.

<u>Commissioner Meeting Calendar:</u> Motion to approve 6pm Work Session by **Commissioner Frost**, no other motions, so the motion died.

<u>Commissioner Meeting Calendar:</u> Motion to approve 9AM Work Session Calendar by **Commissioner Biddle**, seconded by **Commissioner Douglas**. **Commissioner Frost** voted against it. **Chairman Coffey** voted for being the tiebreaker vote. The motion passed.

He would also like to thank Commissioner Biddle for covering the last meeting.



They have been servicing vehicles with oil change, and the longarm has been busy going down various roads.

COUNTY MANAGER UPDATES:

County Manager Weaver – Several board vacancies, Tax Assessors, if anyone knows anyone who would like to serve, please send our way, most boards are volunteer, and they need community input. Commissioner Frost had asked the County Manager to look into a report on county vehicles, and he has that report ready. The County is good on vehicles at the moment, we will only need one vehicle after the lease vehicles get turned in.

The following items were discussed as to their relevance for appearance on the Jan 7, 2025, regular meeting agenda:

Cemetery ByLaws – Add to Work Session for January, Bin will have meeting with Cemetery Committee before.

Purchase of a Sheriff Vehicle – County Manager passed out an email from the Sheriff to the Commission, which was truck vs sedan, the email also stated his assistance with the EMS and why a truck has helped. The County Manager counted nine vehicles, and when the county went to pick up the Tahoe, it wasn't there for them to pick up. We only have 7 positions, 5 deputies, 1 yacant, 1 sheriff, so there is some confusion with vehicles and staffing. Amanda Beaver was in the audience and spoke up saying they aren't in possession of a Charger, 2012 Explorer, The County Manager stated he did not include either of those. He said he would run through all of the ones on his list, Tahoe, 2021 Ford F150, 2019 Ford F150, 2018 Ford F150, 2021 Dodge Charger, 2019 Dodge Charger, and 3 2022 Interceptors, SUVS. Ms. Beaver said the 2021 Explorer is the one they are waiting to be replaced on and they other three interceptors that were purchased are the ones that have to be turned back in in 2027, correct, and the County Manager said stated yes that is correct. She stated she didn't know the Tahoe was being included and he stated yes, because when he told them the Tahoe was going to be picked up, and then when someone went to go get it, it was gone, and then told back in service by the sheriff dept. Commissioner Biddle asked what was the reason for going to get the Tahoe, County Manager stated another office needed a vehicle and if the Tahoe was just sitting and not in use then he was going to let the Coroner use it. Commissioner Hoyte asked about the staffing, Mrs. Beaver replied no they are not at full staff., Chairman Coffey does agree on a truck versus the sedan, and he did not know that they had to assist with EMS, and he does agree that when it is time to replace a vehicle that a truck would be the route to go. Chairman Coffey asked if the Commission is in agreement that this is not an agenda item at this time, they all agreed. Mrs, Beaver asked if this means the interceptor is not being replaced at this time. Chairman Coffey stated the justifiable need isn't there.

Budget Amendment for Superior Court for Additional Staff- Mrs. Tami Wade sent out an email requesting 13,500.00 for additional staffing. It would have to come out of reserve. Chairman Coffey asked if there is a need to add to the agenda, the Commission said no.

Proclamation for James "Jim" Lawrence – Added to agenda as voting item.

Library Board Appointment of Linda Englebert – Added to agenda as voting item.

Zoning Renewal Contract – Added to agenda as voting item.

Attorney Rate Increase - Added to agenda as voting item.




