**Chairman Coffey** called the Regular Monthly Meeting of the *Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia* to order at 6:00 p.m., with all other Commissioners present with the exception of Commissioner Biddle, and live streaming on our Facebook page.

### **SPEAKER**

TERESA PARRISH/JD ABERCROMBIE- Ms. Parrish inquired about grass cutting for the city, the County Manager stated it varies, but we are not doing landscape cutting but that the county is doing utility cutting. JD ABERCROMBIE at 132 Patterson Rd., is speaking on Ms. Parrish behalf, on Sept. 13 she received a citation 10.1.24 Regular Meeting

warning for dirt coming out into the road. The reason he understood why she got the citation was because someone had slid on the road due to the dirt on the road, observations from that, his opinion from that, if the person slid from that they are either speeding or they have bald tires, the speed limit on Massey Rd. is 25 miles on hour, she received the warning on Sept. 19th, with seven days to have the issue corrected. She lives in Lagrange, and works in Lagrange, he stated that Josh Abercrombie, his father David Smith & himself came to her property to clean it up for her. It was half in thick sand, no rock, they cleaned it up with no shovels. His question was about the several other driveways that did the same thing, how many of them received citations on the 13th. The County Manager stated there were ten driveways that day that did receive citations, but the County Manager did state that some were on Hwy 137 and not just Massey Rd. Mr. Abercrombie stated that a code Enforcement officer was sent on Sept. 13th, the same day we were getting two-three inches of rain. He stated that he didn't call about Patterson Rd which was deep in ruts and a foot and a half across, because he knew nothing would be able to be done, but yet someone sent a citation officer that day. Mr. Abercrombie also asked out of all the other driveways how many have been cleaned up. He stated they only have seven days to clean up as residents, but what is the accountability for the county to get things cleaned up. He stated that on the 20th of Sept. he made a work order for Patterson Rd, for the ditches and road fixed. The road was made passable, and the ditch and the pipe were cleaned out, nothing else was done until last night, ten days until after he put in a work order. The County Manager spoke with Ms. Parrish again letting her know that when it rained that was how we know there was an issue with those driveways and that was why the warnings were sent, to inform the residents so they can be informed there is an issue, so it can be resolved. The County Manager said there has to be a formal system in place and the warnings are that system. County Manager stated that the county does what they can with what resources they have, and they put out what fires they can a little at a time, and then they come back at a later date and finish the entire road, but after the storm they did go back and check the road again to be sure it was passable. CHAIRMAN COFFEY stated that this is an issue that has been brought up on two points, one the warning system and a citation and how that's been working, we had a complaint in the last meeting, just so everyone knows a warning is a courtesy and we do not have to give them. We can write someone a citation on the spot, but when it comes to the county, we do what we can do, we might not have the resources to fix everything, but I have the confidence our staff does the best they can with what they have. **Commissioner Frost** also stated that the motor grader was down for repairs as well and that we only have one.

**ATTORNEY** County is being sued, lawsuit is public record, the amount is 5 million dollars, anything about the suit he will discuss in executive session.

County Manager nothing that isn't on the agenda.

<u>Reappoint Ken Vanhorn to Tax Assessors:</u> Motion made by Commissioner Douglas, seconded by Commissioner Hoyte. The vote was unanimous.

**Board Of Elections Policy:** Motion to table to have Second Public Reading at Work Session by **Commissioner Frost**, seconded by **Commissioner Hoyte**. The Vote was unanimous.

<u>Vehicle Purchases:</u> Motion to approve vehicle for BOC to use credit so we do not lose, and table other two vehicles for Sheriff and EMA until December, since we do not know if SPLOST will pass, if EMA needs a vehicle, we can look at the Tahoe that the sheriff dept has, made by **Commissioner Frost**, seconded by **Commissioner Hoyte**. The vote was unanimous.

<u>Cemetery Bylaws:</u> Discussion with Bin on adopting them as rules & regulations, and does the county want to put the bylaws in our ordinance then we will need to do them as an ordinance with public readings, Bin will meet with the cemetery committee next time they meet. Motion to table Work Session by **Commissioner Hoyte**, seconded by **Commissioner Frost**. The Vote was unanimous

One is a lawsuit, and one is an appeal, **CHAIRMAN COFFEY** thanked Bin for the clarification. **CHAIRMAN COFFEY** also stated at the last meeting we had a resident at the last meeting come before them with a matter, County Manager Weaver stated he will cover it at the next Work Session.





**Chairman Coffey** called the Monthly Work Session of the *Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia* to order at 9:00 a.m., with all other Commissioners present, with the exception of Commissioner Douglas and Commissioner Frost and live streaming on our Facebook page.

### **SPEAKER**

**Kristy Laney** – Did not show up in attendance. **CHAIRMAN COFFEY** stated if she came before the meeting was over, he would let her still speak.

### **DEPARTMENT HEAD UPDATES:**

**Mordie Askew:** gave update on the recreation dept., will know after tomorrow night if they make playoffs, breast cancer awareness walk on Oct. 30<sup>th</sup> at 6 pm.

**Samantha Hedgecoke:** gave updates for community development including Christmas tree lighting and Christmas on the Square and Christmas Parade. Public Hearing dates need to be set for 105 Mustang Dr & 454 Old Louvale rd., for Conditional Use Permits., proposed date by commission will be set for Nov. 25<sup>th</sup> at 9 am **Chris Tymes:** out on water calls but did not have any water updates.

Lou Beck: Had a dr. appt, County Manager gave updates for Ms. Lou Beck. Rabies clinic Over 100 dogs & cats were issued rabies vaccines and micro chipped. Wash rack IGSA is going very well.

Tom Bickel: They have fixed plumbing issues at public works shop, all of the roads have been worked, the animal control truck has been fixed, the motor grader has been fixed, work at riverbend park dock, there was a cross drain that went out & it is repaired now. The shoulder at 137/Pifer has been taken care of, Ralston St, they went over there and got it working good again. They were able to install the trashcans and install the flagpole. They got the slab poured for the new radio building, and they have new radios for all the crew at public works.

**CHAIRMAN COFFEY** stated a concerned citizen asked about the road washing behind the cemetery, if the county could look into this.

### COUNTY MANAGER UPDATES:

County Manager Weaver — We are in the ACCG local lens, one is for a grant we received for AED's with Sumter EMC. The Fiber install is going well, they have hit a few water lines, but Chris is right behind them fixing them as they go. At the radio tower where the slab was poured, the building is on way to be placed. We are live with the Paychex system. The reading garden that Ms. Pam is working on is very nice and moving right along, it did not cost the county anything it came out of the Library Construction funds. County Manager stated those were his normal updates, now he is moving into his budget updates, first thing is the annual audit with David McCoy ran into somethings he did not like, so before he can move forward, he wants to go back over the previous audits. All of the departments are on track, no major overages at this point, everyone is where they should be at this point. We will have another update at the beginning of the year, which will be the halfway point.

The following items were discussed as to their relevance for appearance on the Oct. 1, 2024, regular meeting agenda:

**Old City Hall Building to be used by Board of Education** — Bin sent over document to look over and review, add to agenda as voting item.

**Johnny Floyd/Truck for EMA** – After last month's meeting the two vehicles were voted down, The County Manager stated that there will be four trucks coming out of the lease program going back, Johnny has one truck deadlined, he is trying to avoid replacing five or six vehicles next budget year. -add to agenda as voting item.

**Board of Elections-2**nd **Reading** – Ordinance Change, and have a three-member Board of Elections, we also have three names for members for after the second reading and the Board is approved, Nancy Hoard, Valerie Lassiter, and Crystal Walker, and the Election Supervisor Lisa Bickel the names are for the Work Session - add to agenda as voting item.

Bringing Paul Rakel/Sowega as Engineer of Record – County Manager is going to look at several different names and bringing to back to the Work Session instead.

**Cemetery Bylaws** – Waiting and setup a meeting with Bin and the Cemetery Committee, keep on just in case, add to agenda

Reappoint Mattye Kinney to IDA – add to agenda as voting item.

Reappoint Gene Burgamy to IDA – add to agenda as voting item.

HB 581/FLOST – just discussion and fyi item. County Manager stated the F stood for Freeze, Alan Horniday was in attendance, and stated if this passes there will be three buckets to choose from, ESPLOST, TSPLOST, and FLOST, educational, transportation, and freeze, it will freeze at the 2024 taxable value. So, the sales tax will not become immediate, it will have to go through a referendum, but the County will have to opt in and be opted in already. This is also not split with the school; it is just for the county. It would benefit the homesteaded properties. If this is approved the county is automatically in. The County Manager and Commissioner believe this would be a good opportunity for the County.
