RESOLUTION NO. 2024-2

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE UNIFIED **CUSSETA-CHATTAHOOCHEE** GOVERNMENT OF COUNTY, GEORGIA. IMPOSING AND CONTINUING A COUNTY ONE PERCENT (1%) SALES AND USE TAX AS AUTHORIZED BY PART 1 OF ARTICLE 3 OF CHAPTER 8 OF TITLE 48 OF THE OFFICIAL CODE OF GEORGIA ANNOTATED, SPECIFYING THE PURPOSES FOR WHICH THE PROCEEDS OF SUCH TAX ARE TO BE USED; SPECIFYING THE PERIOD OF TIME FOR WHICH SUCH TAX SHALL BE IMPOSED; SPECIFYNG THE ESTIMATED MAXIMUM COST OF THE FACILITIES TO BE FUNDED FROM THE **PROCEEDS OF** SUCH TAX: AND REQUESTING THE ELECTION SUPERINTENDENT TO CALL AN ELECTION OF THE VOTERS OF CUSSETA-CHATTAHOOCHEE COUNTY TO APPROVE THE IMPOSITION OF SUCH SALES AND USE TAX; APPROVING THE FORM OF BALLOT TO BE USED IN SUCH AN ELECTION; AND FOR OTHER PURPOSES.

WHEREAS, Part 1 of Article 3 of Chapter 8 of Title 48 of the Official Code of Georgia Annotated, (the "Act") authorizes the imposition of a one percent (1%) sales and use tax designated as a Special Purpose Local Option Sales Tax (the "SPLOST") for the purpose of, among other things, financing certain capital outlay projects which include those set forth herein; and

WHEREAS, Cusseta-Chattahoochee County is a unified government with powers and jurisdiction throughout the territorial limits of Cusseta-Chattahoochee County which has been vested with the governmental and corporate powers, duties and functions previously vested in the City of Cusseta and the County of Chattahoochee, as specifically set forth in the Cusseta-Chattahoochee Charter, Georgia Laws 2004, page 4811; and

WHEREAS, the Board of Commissioners of Cusseta-Chattahoochee County, Georgia (the "Board of Commissioners") has determined that it is in the best interest of the citizens of Cusseta-Chattahoochee County, Georgia (the "County") that a one percent (1%) SPLOST be imposed in the County to raise not more than EIGHT MILLION DOLLARS (\$8,000,000.00) for the purpose of funding capital outlay projects (the "Projects"); and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Cusseta-Chattahoochee County, Georgia as follows:

A. Assuming the question of the continuance and imposition of a County SPLOST is approved by the voters of Cusseta Chattahoochee County, Georgia in the election hereinafter referred to, the SPLOST shall be continued and imposed for the term, purposes, and costs as follows:

- 1. In order to finance the Projects described herein, a SPLOST in the amount of one percent (1%) on all sales and use taxes in the County is hereby authorized to be levied and collected within the County as provided in the Act.
- 2. The proceeds of such tax are to be used to fund the Projects. The Projects consist of "County Projects". The County Projects and their estimated maximum costs are set forth below.

- 3. The SPLOST is to be imposed for a period of five (5) years.
- B. Call for the Election; Ballot Form; Notice.
 - 1. The election Superintendent of Cusseta-Chattahoochee County is hereby requested to call an election in all voting precincts in the County on the 5th day of November 2024, for the purpose of submitting to the qualified voters of the County the question set forth in paragraph 2 below.
 - 2. The ballot to be used in the election shall have written or printed thereon substantially the wording described on Exhibit "B" attached hereto.
 - 3. It is hereby requested that the election be held by the Election Superintendent of Cusseta-Chattahoochee County in accordance with the election laws for the State of Georgia, including, without limitation, the election laws relating to special elections. It is hereby further requested that the Election Superintendent of Cusseta-Chattahoochee County canvass the returns, declare the results of the election and certify the results to the Secretary of State and to the State of Revenue Commissioners.
 - 4. The Election Superintendent of the Cusseta-Chattahoochee County is hereby authorized and requested to publish a notice of the election as a required by law in the newspaper in which Sheriff's advertisements for the County are published once a week for four weeks immediately preceding the date of the election. The notice of the election shall be in substantially the form attached hereto as Exhibit "A".

This agreement is made as of December 19, 2023 by and between Unified Government of Cusseta — Chattahoochee County (Client) and Barge Design Solutions, Inc. (BARGE) for professional services for the assignment described as follows:

Project: Engineering Work for Defense Community Infrastructure Pilot Program

Location: Columbus, GA

Description of Project:

The UGOCCC is looking at options for sanitary sewer service to provide opportunities for growth in the county by attracting commercial industry along their Highway 520 and Highway 27 corridor. This project consists of preparing an engineering report to compare up to three alternatives to provide reliable sanitary sewer service to the area.

I. PROFESSIONAL SERVICES: BARGE agrees to perform the following Basic Services under this contract:

Barge will provide the services described in Exhibit A.

II. COMPENSATION: Client shall compensate BARGE for the Basic Services as follows:

In addition, Client shall pay BARGE for additional services performed beyond the Basic Services in accordance with the hourly rate schedule attached as Exhibit "A" to this Agreement.

- III. PAYMENTS: Invoices for services rendered will be issued monthly, and payment is due upon receipt of each invoice. Unless special arrangements are made, a finance charge of 1.5% per month will be added to unpaid balances more than thirty (30) days old. In the event BARGE is successful in any legal action to enforce the payment terms of this agreement, BARGE shall be entitled to a judgment for its reasonable attorneys' fees, court costs, and other legal expenses.
- IV. TIME: Unless agreed otherwise in writing, BARGE will commence its services within a reasonable time after receipt of an executed copy of this Agreement, which in any case shall not exceed 30 days, subject to the conditions below in this Section IV. BARGE will perform its services in a timely manner commensurate with the exercise of due professional care. Time for performance shall be extended as necessary for delays or suspensions due to circumstances beyond BARGE's control. If such delay or suspension extends more than three months (cumulatively), BARGE's compensation shall be equitably adjusted.

- C. The Clerk of the Board of Commissioners is hereby authorized and directed to deliver a copy of the resolution to the Elections Superintendent of Cusseta-Chattahoochee County with a request that the Election Superintendent of Cusseta-Chattahoochee County issue the call for and election.
- D. The proper officers and agents of the County are hereby authorized to take any and all further actions as may be required in connection with the imposition of SPLOST.
- E. The Resolution shall take effect immediately upon its adoption.

- V. SUSPENSION OF SERVICES: If Client fails to pay any invoice when due or otherwise is in material breach of this Agreement, BARGE may at its sole discretion suspend performance of services upon fifteen (15) days' written notice to Client. BARGE shall have no liability to Client, and Client agrees to make no claim for any delay or damage as a result of such suspension. Upon cure of the cause of the suspension, BARGE shall resume services within a reasonable time, and there shall be an equitable adjustment of the project schedule and fees to reflect the effects of such suspension.
- VI. STANDARD OF CARE: Notwithstanding any other provision of this Agreement or any other document describing the services, BARGE shall perform its services in accordance with the standard of professional care ordinarily exercised under similar circumstances by reputable members of its profession in the same locality at the time the services are provided. No warranty, expressed or implied, is made or intended by BARGE. The parties further agree that BARGE is not a fiduciary of Client.
- VII. TERMINATION: The obligation to provide further services under this Agreement may be terminated without cause by either party upon thirty (30) days' written notice to the other party. On termination by either the Client or BARGE, Client shall pay BARGE all amounts due for any services performed to the date of termination (plus all reimbursable expenses incurred).
- VIII. OWNERSHIP AND REUSE OF DOCUMENTS: All documents, including without limitation, drawings, specifications, and reports prepared by BARGE pursuant to this Agreement are instruments of professional service. BARGE shall own all legal and equitable rights therein, including copyrights. Such instruments are not intended or represented to be suitable for reuse by Client or others for additions or modifications of the Project or on any other project. Any reuse without written consent of BARGE shall be at Client's sole risk and without liability to BARGE; and to the fullest extent permitted by law, Client shall indemnify, defend, and hold harmless BARGE from and against any and all claims, damages, losses, and expenses, including reasonable attorneys' fees and costs of defense arising out of or resulting therefrom. BARGE shall be entitled to further compensation for services it is requested to perform in connection with any reuse of its instruments of professional service.
- IX. ACCESS TO THE SITE/JOBSITE SAFETY: Unless otherwise stated, BARGE will have access to the site for activities necessary for the performance of its services. Client agrees that BARGE shall have no responsibility for the means, methods, sequences, procedures, techniques, and scheduling of construction, as these decisions are solely the responsibility of the contractors. BARGE further shall have no authority or duty to supervise the construction workforce and shall not be responsible for jobsite safety or for any losses or injuries that occur at the Project site.
- X. INSURANCE: BARGE shall provide evidence of insurance coverage in the following minimum amounts:

XI. RISK ALLOCATION: In recognition of the relative risks, rewards, and benefits of the Project to both Client and BARGE, to the fullest extent permitted by law, the parties agree to allocate the

risks such that **BARGE's** total liability to **Client** for any and all injuries, claims, losses, expenses, damages, and/or claim expenses arising out of **BARGE's** services under this Agreement from any cause or causes shall not exceed the limits of insurance proceeds available. Both parties agree to a waiver of consequential damages. This limitation shall apply regardless of the cause of action or legal theory pled or asserted.

- XII. DISPUTE RESOLUTION: It is agreed that all claims, disputes, or other matters in question arising out of or related to this Agreement shall be submitted to nonbinding mediation before any legal proceeding is commenced. The parties shall equally bear the fees and expenses charged by the mediator.
- XIII. OPINIONS OF CONSTRUCTION COST: Any opinion of probable construction cost prepared by BARGE represents the judgment of one or more BARGE design professionals and is supplied for general guidance of Client. Since BARGE has no control over the construction marketplace and does not use the same pricing methods used by contractors, BARGE does not guarantee the accuracy of such opinions.
- XIV. GOVERNING LAW: Unless otherwise specified within this Agreement, this Agreement shall be governed by the laws of the State of Georgia. Venue shall be the United States District Court for the Middle District of Georgia or the Superior Court for Chattahoochee County, Georgia.

HR – LEAVE MANAGEMENT Annual Leave 420.03

PURPOSE

Annual leave is a type of paid leave accrued by an employee based on length of service and utilized under certain conditions. Annual leave is considered a benefit for eligible employees.

POLICY

There shall be a consistent process for the accrual and use of annual leave of regular full-time and part-time County employees.

PROCEDURE

Eligibility for Annual Leave

All regular full-time and regular part-time employees of Chattahoochee County shall be eligible to accrue annual leave.

Accrual Rate of Annual Leave

Vacation will be accrued every pay period beginning July 1st.

Employees employed under three years will accrue **1.54** each pay period to a total of **40** hours.

Employees employed over three years will accrue **3.077** each pay period to a total of **80** hours.

If you request vacation for hours not accrued, it will be left at the discretion of your director to allow the time to be taken, however if allowed it will put your vacation time in the negative. Final approval will be at the discretion of the County Manager.

Maximum limit of annual leave to be in the negative at one time not to go over 40 hours.

If an employee quits or is terminated with their vacation time in the negative it will be deducted from their final check.

New employees will be prorated for vacation time after they satisfactorily fulfill their 90 days introductory period per pay period.

The earliest possible notice of intent to take annual leave shall be given by employees who are eligible to take annual leave. A request for annual leave shall be submitted to the employee's immediate supervisor a minimum of five days in advance.
