Upon the manager's calling the roll, with all Commission members present, **Chairman Coffey** called the Public Hearing II of the *Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia* to order at 6:00 p.m. and livestreaming on Facebook.

CHAIRMAN COFFEY stated that the millage rate would be staying the same as the previous year of 2022 and 2020, which was 8.502. He stated that the newspaper can be misleading. That if there was an increase in taxes it was due to an appraisal value increase, he also noted that the school went down from last year to 17.010.

With no one to speak **CHAIRMAN COFFEY** closed public forum.

COMMENTS BY COMMISSIONERS:
