June 4, 2024

Chairman Coffey called the Budget Public Hearing I of the Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia to order at 6:00 p.m., with all other Commissioners present except for Commissioner Hoyte, and live streaming on our Facebook page.

BUDGET PUBLIC HEARING I

County Manager Weaver stated when we sent out the request to the departments for their budgets and when we got them back, we were just shy \$2,000,000.00 over budget what our revenue will bring in. Last work session County Manager brought several line-item adjustments and cuts where he had made that brought us down to 1.4 million still off, he has since then made more adjustments and cuts to the budget and we are currently 621,000 off, which is not perfect, he feels if he makes more cuts at this moment, it would be necessarily not educated or not thought out. He would like to recommend that the Commission pass the budget by going into the reserve account. Chairman Coffey stated he found some cuts in the budget around \$300,000.00, the biggest department being Public Safety and he believes we should look at these numbers, another is EMS since it in brand new. Chairman Coffey also brought up surrounding counties and how they have a lot bigger areas to patrol and, but we are spending more money. Chairman Coffey stated if after we put our heads together and look at these other departments and the County Manager still says we would need to come out of the reserve he will respect that to, but when these departments need an amendment, they need to start coming and asking and explaining why they need one. County Manager Weaver stated that the county needs to have an actual contingency plan. Commissioner Frost stated he wanted to bring up thinking outside the box with staffing, by having someone as a floater to help with all offices. Commissioner Biddle stated that he just wanted to thank County Manager Weaver and he doesn't hold him accountable for where we were and thank him for getting us where we are now. County Manager Weaver would like to start working on a budget earlier instead of waiting to do everything in a 90-day timeframe. David Smith was in attendance and approached the podium to speak he inquired on the surrounding counties Chairman Coffey had brought up earlier, he thinks the federal government should help us out more. County Manager Weaver stated we will do ok with water they are their own funding source. He also gave the Commission the IGSA figures which he didn't think he was going to be a fan of coming into the position, but he has since changed his mind. Chairman Coffey stated he just wants the people to know if we are going to have to start going into the reserve to balance the budget there are two fixes to it, either cutting expenses or raising taxes. This is what is

presented to them, and they must be the bad guys for it. **County Manager Weaver** stated he isn't thrilled to bring them the budget with this deficit, but it will take some time and effort to get it balanced, and it will need some more changes that will probably not make a lot of people not happy, but at some point, you got to snatch that band aid off and get it done.

Motion to adjourn the Budget Public Hearing I made By Commissioner Frost, Seconded by Commissioner Douglas. The vote was unanimous.

County Manager has been in contact already with an auditor, the one we had started to use Mr. David McCoy. Other updates are LMIG, we received the 155,000.00 check for LMIG and now we are applying for the supplemental and we are applying for that as well and will get a total of 350,000.00

There was a state law passed every county with a probate judge as an election superintend this will be no more, this gives the Board the authority to create a Board of Elections. Therefore, he will draft an ordinance for the creation of a Board of Elections. Things to consider how many members, appointment powers. A county resident Blaize Angol has written several letters to the sheriff dept, some seem legal but not filed that way. He will hand them over to **County Manager Weaver** to look at and put on the Work Session.





WHEREAS, the Unified Government of Cusseta-Chattahoochee County ("UGOCCC") is vitally interested in the prevention, detection and suppression of forest fires in Cusseta-Chattahoochee County, Georgia: and

WHEREAS, the Georgia Forestry Commission ("Forestry") is empowered and has authority to conduct and direct fire prevention work and maintain equipment, personnel and installments for the detection, prevention, and combating of forest fires; and

WHEREAS, the UGOCCC has sufficient resources and authority to assist Forestry in the detection, prevention, and combating of forest fires in Cusseta-Chattahoochee County; and

WHEREAS, Forestry has the authority to contract with instrumentality of county and unified government for the advancement of the forests of this State; and

WHEREAS, the UGOCCC and Forestry are poised to enter into an Agreement to provide direct Fire Tower protection for Cusseta-Chattahoochee County and its residents.

NOW, THEREFORE, in the consideration of mutual covenants and benefits flowing to and from each party to this Agreement, the UGOCCC hereby resolves to honor the Agreement by and between the UGOCCC and Forestry, and Authorizes the Chairman to execute said Agreement.



THE UNIFIED GOVERNMENT OF CUSSETA-CHATTAHOOCHEE COUNTY FIRE TOWER AGREEMENT

THIS AGREEMENT is made and entered into this 4th day of June, 2024 by and between GEORGIA FORESTRY COMMISSION, a department or agency of the State of Georgia, hereinafter called "Forestry", and UNIFIED GOVERNMENT OF CUSSETA-CHATTAHOOCHEE COUNTY, a political subdivision of the State of Georgia by and through its Board of Commission, the governing body for the UNIFIED GOVERNMENT OF CUSSETA-CHATTAHOOCHEE COUNTY, hereinafter called "UGOCCC".

WITNESSETH:

WHEREAS, the UGOCCC is vitally interested in the prevention, detection and suppression of forest fires in Cusseta-Chattahoochee County, Georgia; and

WHEREAS, the Forestry is empowered and has authority to conduct and direct fire prevention work and maintain equipment, personnel and installments for the detection, prevention, and combating of forest fires; and

WHEREAS, the UGOCCC has sufficient resources and authority to assist Forestry in the detection, prevention, and combating of forest fires in Cusseta-Chattahoochee County; and

WHEREAS, the Forestry has the authority to contract with instrumentality of county and unified governments for the advancements of the forests of the State; and

NOW, THEREFORE, in the consideration of mutual covenants and benefits flowing to and from each party to this Agreement, Forestry and the Unified Government of Cusseta-Chattahoochee County agree as follows:

- 1) The UGOCCC agrees to pay the Georgia Forestry Commission in consideration for the Georgia Forestry Commission's provision of personnel assistance with respect to the detection, prevention, and combating of forest fires in Cusseta-Chattahoochee County. The UGOCCC's payment per contract period shall not exceed Four Thousand Seven Hundred Thirty Eight Dollars and Fifty Eight Cents (\$4738.58). Georgia Forestry Commission shall submit a bill to the UGOCCC for payment at the end of the contract period.
- 2) Forestry agrees to select and employ a Fire Tower operator(s) who will be assigned to the Cusseta-Chattahoochee County Forestry Unit for employment duties as a fire tower operator. The fire tower operator(s), so selected, shall be a temporary employee day laborer. He/she shall not work more than 40 hours per week. When someone in this position is not available to meet the obligations of detection, prevention, and combating of forest fires other full time employees will be utilized if possible. The hourly rate charged for a full time employee will not differ from the Fire Tower operator. Local residents will be utilized to fill the position when possible.

- Forestry agrees to submit to the UGOCCC, at such intervals as may be necessary, documentation confirming the assistance received by Forestry from the UGOCCC.
- 4) This agreement shall become effective July 1st, 2024, and shall remain in effect until June 30th, 2025.
- 5) Either party may terminate this Agreement at any time upon thirty (30) days written notice to the other party.
- 6) For the purpose of notice, and other writing called for by this Agreement or delivered between the parties of this Agreement, the parties' addresses shall be as follows:

Chairman Coffey called the Monthly Work Session of the *Commission of the Unified Government of Cusseta-Chattahoochee County, Georgia* to order at 9:00 a.m., with all other Commissioners present, with the exception of Commissioner Frost and live streaming on our Facebook page.

SPEAKER:

Pam Burgamy would like permission to use the property belonging to the county beside the library for a garden. She would use the remainder of the construction funds and put-up fencing so the children can sit and read around the garden, and they can also have story time in this area. It will also need to be ADA compliant. Mrs. Burgamy also mentioned the current fence that is behind the library needs to be treated so it will last longer. Commissioner Douglas had concerns about the piece of land and wanted to be sure the fire department did not need it to expansion of building use, but County Manager Weaver and Commissioner Biddle assured him that this piece of land was not going to be used for the fire department. Chairman Coffey stated if it does not require a vote we can move forward, if it does, we will put on next Work Session so that we can vote on it and approve it.

COUNTY MANAGER UPDATES:

County Manager Weaver — we have started receiving payments for ambulance fees. We had a meeting with Charter, Spectrum, and Bingham construction, and they are going to put in fiber all over Chattahoochee County. They project to be in service mid-December. There will be locates everywhere, hopefully it will reach a good majority of the county. They will come through Ft. Moore, then Hwy 26, Industrial Park Rd, and Broad St., and spread out from there, we aren't sure where they will go from there, but we do know they will have about 90% of the County covered when they are just about done. The Long arm is finally back in service after being gone for months. The cemetery will be complete as of this week, the final step will be the hydroseed. The LMIG has been submitted and approved, the total of both is around \$355,000.00. The application for the sewer grant has been completed and accepted.

Department Head Updates:

Teri Hancock- gave updates for water department, Chris Tymes is out on a water call. The CCR report is complete and has been submitted. The drying beds have been completed at Well 2 & 3.

Mordie Askew - gave updates for the recreation department, they will have a back to school party at the end of July and hopefully they can get the community involved.

Samantha Hedgecoke - they had the rabies clinic & the car show, both events went really great and had a great turnout.


