<u>Adoption of Millage Rate 8.502:</u> Motion made by **Commissioner Hoyte** to approve and keep the same millage rate as last year, seconded by **Vice Chairman Biddle.** The vote was unanimous.

TRANSIT AUTHORITY APPOINTMENT OF TWO MEMBERS: Motion made by Commissioner Frost and seconded by Commissioner Hoyte to appoint Tim Biddle and Gerald Douglas to the Transit Authority. The vote was unanimous.

Motion made to close meeting and go into Executive Session at 6:19 pm made by **COMMISSIONER FROST** seconded by **COMMISSIONER BIDDLE**. The vote was unanimous.

RECONVENED REGULAR MEETING AT 7:35 pm

CHAIRMAN COFFEY discussed updates from attorney & topics discussed in executive session, they were that the quiet action title deed will no longer need to require help from the attorney, the historic society has done a quick claim deed, however we do not know the status on if they have filed with the Clerk of Superior Court. He also mentioned we have a few more things to be finalized with our IGSA agreements, but that they should only need the signature of the **County Manager** and not require the **CHAIRMANS. CHAIRMAN COFFEY** also noted there should not have to be any changes with the peddler's ordinance at this time as well, there

were some questions when the rodeo came as to if we needed to change it, and we do not. There has also been some research on 242 Firetower Rd, and the drainage issues to a customer's driveway, still some research to be done, but bottom line the county is not responsible for private driveways. Line items that need to be added to budget are Animal Shelter and all IGSA's. Chattnet deposits need to be looked into because they aren't showing any recent deposits, and they used to. **CHAIRMAN COFFEY** stated all other items discussed were personnel and pending legal issues.
