April 12, 2021 – Regular Monthly Meeting @ Town Hall – 7:30 pm.

Notice of the meeting was posted according to the OML, {19.84 (3)} on the town website and published in the Ad Delite.

The chairman called the meeting to order at 7:30 pm. All board members were present along with the Sherri McCormick the new clerk and several from the community.

The Pledge of Allegiance was said.

The agenda was approved on a motion made by Matt Krenz and second by Dean Klingbeil and carried.

The minutes were read with one correction on the time of the safety meeting held on April 8th being 8:30 and again at 5:00 rather than all day. A motion to approve was by Matt Krenz and seconded by Dean Klingbeil and carried.

The Oath of Office was given to the chairman, clerk, treasurer, and board members to sign and later spoken.

The Public Mailings included: A highway 12 project to be done in 2025, resident Laura Steele inquiring about making a bike trail from Fall Creek to Beaver Creek, also a reminder to not take the survey markers out while digging. Eau Claire County will receive a Covid-19 Stimulus Package, American Rescue Plan Act, it will be distributed to the townships.

Public Input: Dennis Schiefelbein told of the bad condition some of our town roads are in and was wondering why the \$30.00 wheel tax to the county has not been used for the roads as it was intended. Dennis suggested someone from the Highway Committee come to the annual meeting to address the issue. Ken Kiesow reported 188 voters cast ballots for the April 6th election at 25% exceeding the state average of 20%. Eric Crawford told of the revenue that the county (60%) and township (40%) would receive from the 26 million over the life of the Wind Tower Project.

Items for tonight meeting: A.

A culvert will be ordered for Gabler on a motion made by Matt Krenz and seconded by Dean Klingbeil and carried.

B. The Annual meeting will be held April 20th at 7:30pm.

Road and Town Business: Hopes of using the Covid allocations for repair of some of the roads that are in need will be looked at.

Future Agenda: Open bids for granite rock and base coarse. Ordinance for Wind Towers.
