February 8, 2021 – Regular Monthly Meeting @ Town Hall - 7:00pm

Notice of the meeting was posted according to the OML, {19.84 (3)}, and published in the Ad Delite. The chairman called the meeting to order at 7:00pm. All the town board members were present along with several from the community.

The agenda was approved on a motion made by Matt Krenz, Dean Klingbeil seconded, and it carried.

The minutes of the last meeting were read and approved on a motion made by Dean Klingbeil and seconded by Matt Krenz, the motion carried.

The monthly mailings included a refund check because of Covid from Rural Insurance, Board of Review training reminder, Farrell open house in March and information on the census.

Public Input included complaints about residents having broken fence with animals getting out and going to neighboring yards. A dead carcass has been thrown by the road. Dogs barking and coming to the neighbor's buildings were also in the complaint. A board member will be talking to the owner of the party in question and seeing what can be done.

Item 8 a – Members of the Big Creek ATV Club presented maps of Lincoln and nearby township where they would like roads opened for ATV travel. It was discussed how to mark the roads with signs and some needs for changes on the Town of Lincoln ordinance on ATV'S. The club will be applying to the Highway Commissioner for an application.

Item 8b – The culvert on Hillview Drive will be again looked at but other than major changes it seems unlikely it will be able to be corrected at this time.

Item 8c – The current wages for the poll workers and audit committee will be again looked next month after talking with other townships.

Item 8d- It was decided to sell the computer for \$250.00.

Item 8e- The prices on the Sand Contract will remain the same as they have been. Information will be updated and reviewed next month and sent out in April. The security codes for the machines will be changed.

Road and Town Business – It was brought up the need for more sanding on the township roads with the slippery conditions being dangerous.

Future agenda items will include, poll workers, audit workers and special committees' wages. Wind towers, retirement plan and ordinance on dead animals, updated sand contract and road bans along with the ATV ordinance.

The treasures report was heard. GENERAL FUND - \$846,435.56, MACHINE FUND - \$63,018.94, TOWN HALL FUND - \$14,067.70, PETTY CASH – 34.00, TOTAL OF TONIGHTS BILLS \$31,077.68. A motion to accept the treasures report was made by Dean Klingbeil and seconded by Matt Krenz and carried. On a motion made by Matt Krenz and seconded by Dean Klingbeil the treasure will move the money to pay the bills, the motion carried.

From the machine fund \$30,000.00 will be placed in a CD for 24 months at a rate of .698%. The motion was made by Matt Krenz and seconded by Dean Klingbeil and carried.

The next meeting was set for March 8, 2021 at 7:00 pm at the town hall.

The meeting was adjourned at 8:12 pm on a motion made by Dean Klingbeil and seconded by Matt Krenz.
