Item c. The fuel contract will go with River Country for 2500 LP gallons at .99, should the price go down we will get it at the lower cost. Dean Klingbeil and Matt Krenz will be looking into prices for diesel fuel to be discussed at next meeting.

Item d. Budget options for the 2021 draft will include increase for ambulance, employee retirement and clerk and treasurer pay.

Item e. The culvert at Gables was to wet to inspect at this time.

Item f. There are two grants for the Covid expenses, Route to Recovery \$18,745.00 and the WECARE grant \$955.92. We will be using each for the added voting expense.

Road Business included: Strawberry Road needs to be trimmed and widened; the Village of Fall Creek is buying three loads of gravel. Those not paying for their sand will be again contacted.

Future Agenda will be: Reviewing the budget draft – Change in collecting taxes in view of the Corona Virus – Culvert at Gablers – Fall Creek Area Fire Department budget. There will also be a closed meeting to review employee performance.

The Treasurers Report was read and accepted and a motion along with moving the money for tonight's bills by Matt Krenz and accepted by Dean Klingbeil. General Funds as of 8-31-2020: Unity Bank \$412,657.35 Petty Cash \$75.00 Land Use Account \$114.56.
