Indian Run Preschool is a half-day program for children ages 3-5. Our morning session is 9:00-11:30 and our afternoon session is 1:00-3:30. In addition, we offer a Frog Plus class that is 9:00-1:00 Monday through Thursday. The children will pack a lunch to eat each day in the Frog Plus class.

**MISSION STATEMENT** Indian Run United Methodist Church's Preschool is an outreach ministry of the Indian Run United Methodist Church. We provide a Christian environment to nurture the intellectual, social and spiritual growth of young children through a developmental and play-based curriculum.

**CLASS OFFERINGS** The following classes are available depending on your child's age.

- Frog Plus/Pre-K (4/5 year olds): Child must be 5 by 5/31/2027 and attending kindergarten the following year.
- Frog class/Pre-K (4/5 year olds): Child must be 5 by 5/31/2027 and attending kindergarten the following year.
- Frog Pond (Frog Enrichment class): Child must be 5 by 5/31/2027.
- Owl class (4 year olds): Child must be 4 by 9/30/2026.
- Owl Treehouse (Owl Enrichment class): Child must be 4 by 9/30/2026.
- Firefly class (young 4s): Child must be 4 by 2/28/2027.
- Firefly Meadow (Firefly Enrichment class): Child must be 4 by 2/28/2027.
- Manatee class and Turtle class (3 year olds): Child must be 3 by 9/30/2026.
- Under the Sea class (Manatee and Turtle Enrichment class): Child must be 3 by 9/30/2026.

**FEES** A non-refundable registration fee of \$100 for the first child (\$50 for each additional child) plus the May 2027 tuition will be due upon enrollment. A non-refundable supply fee will be due in August 2026. The supply fee is based on the number of days your child attends.

1-day per week: \$40

2-days per week: \$80

3-days per week: \$120

4-days per week: \$160

Tuition will be due monthly from September through April.

**REGISTRATION DATES** Our registration process is based on a lottery.

**Current families, church members, alumni families, and current PMO families** can drop off registration between December 1 and December 5, 2025. The lottery for this group will take place on Monday, December 8, 2025. Class lists will be posted on December 9, 2025.

**New families** can drop off registration between January 6 and January 12, 2026. The lottery for this group will take place on January 13, 2026. Class lists will be posted on January 14, 2026.

**REGISTRATION STEPS** To be assured of placement in the lottery, all application steps must be completed.

1. Complete the Registration Form, indicating your 1<sup>st</sup> and 2<sup>nd</sup> choice.
2. Read, sign, and date the Tuition Agreement.
3. Include a check for the \$100 non-refundable registration fee (\$50 for each additional child). Checks should be made out to "Indian Run Preschool."
4. Place the above information in an envelope labeled **Preschool Registration**. All siblings can be placed in one envelope.
5. Drop off your envelope in the "Registration" box in the preschool, in the green church mailbox located in the parking lot, or mail it to:

6. Once notified of your placement, send a check for May 2027 tuition as your acceptance to the class. Checks should be made out to "Indian Run Preschool."

\*All forms (other than the registration form) will need to be filled out 30 days prior to the start of the school year. These forms are on our website, and you will receive instructions in the mail over the summer.

\*Your child will need to have a current physical on file at the start of the school year. Physicals expire after 13 months, and all physicals must remain current throughout the school year. You can find this form on our website under the Forms tab. It is called **Child Medical Statement**.
