Building and Grounds Report -- July 13,2021

A leak was found in the coil of the AC unit at the choir loft during Professional Heating and Cooling's PM Inspection. Merrill is getting a second quote to fix the problem. Meanwhile freon has been put in it because of the leak.

Merrill, Tim, and Susan inspected the insulation on the same unit's freon lines, found some bare areas and reinsulated where needed. Freon lines on the back two units were re-insulated also. Bill W, Tim and Susan cleared the path beside the older kid playground to get from the front to the back. The mowing crew will include the area in their yard maintenance.

Merrill has completed repairs to the Ladies Room toilet holders, desk in choir room, ongoing doorstops and other projects. He replaced a kitchen faucet on one of the back sinks.
