

DOG BOARDING AGREEMENT



This Dog Boarding Agreement is a binding agreement between the pet owner and the boarding facility for the care and boarding of the owner's dog(s). It sets forth the responsibilities of both parties and the terms under which boarding services will be provided. By signing this agreement, the owner acknowledges that they have read, understood, and agree to comply with all terms and conditions contained herein.

Terms and Conditions

1. **Boarding Period:** Boarding begins and ends at the times specified by the facility at drop-off and pickup. Late pickups may incur additional fees, and the facility must be notified promptly of any changes to the agreed boarding schedule.
2. **Payment Terms:** Payment is due at the time of drop-off unless another arrangement has been agreed to in writing. Late payments may incur fees, and all charges will be based on the facility's current pricing at the time services are provided.
3. **Health Requirements:** All dogs must be current on required vaccinations, including rabies, DHPP, and Bordetella. Dogs must be free from contagious illnesses and kept on current flea and tick prevention before and during boarding.
4. **Liability:** The facility will exercise reasonable care in supervising and caring for boarded dogs. However, the facility is not liable for injury, illness, or death resulting from pre-existing conditions, undisclosed health issues, or incidents beyond its reasonable control.
5. **Emergency Medical Care:** If a dog requires medical attention, the facility is authorized to seek veterinary care as needed. The owner is responsible for all related medical

expenses, and the facility will attempt to contact the owner before obtaining treatment whenever practicable.

6. Cancellation Policy: Cancellations must be made within the time period required by the facility to avoid charges. Late cancellations or failure to arrive may result in applicable cancellation fees or forfeiture of deposits.

Owner Responsibilities

- Provide accurate and complete health information, including vaccination history and any known medical conditions.
- Supply all necessary food, medications, supplements, and clear feeding instructions for the boarding period.
- Ensure the dog is properly identified with tags, microchip information, or other identification as applicable.
- Disclose any behavioral issues, aggression, separation anxiety, escape tendencies, or special handling needs.
- Maintain current contact information so the facility can reach the owner or emergency contact at all times.

Facility Responsibilities

- Provide safe, clean, and comfortable accommodations for all boarded dogs.
- Feed dogs according to the owner's instructions and any approved dietary requirements.
- Administer medications as directed by the owner, when clearly labeled and permitted by the facility.
- Monitor dogs for signs of illness, distress, or unusual behavior and respond appropriately.
- Provide exercise and socialization as appropriate based on the dog's needs and temperament.

Behavioral and Safety Policies

Dogs that display aggressive, disruptive, or unsafe behavior may be separated from other dogs or required to be picked up early. The facility reserves the right to refuse service to any dog whose behavior presents a risk to staff, other animals, or property. Owners must fully disclose any known behavioral concerns, including aggression, anxiety, escape tendencies, or reactivity. The facility is not responsible for injuries that occur during normal play, interaction, or supervised group activity with other dogs.

Personal Belongings

The facility will make reasonable efforts to care for personal items such as toys, bedding, blankets, collars, and other belongings brought with the dog. However, the facility is not responsible for the loss, theft, or damage of these items. Owners should clearly label all belongings to help reduce confusion and support proper return at pickup.
