1. Boarding Rates & Payment Policy

Nightly boarding rate: \$40 per night, per dog. Rates are subject to change at the discretion of the Facility.

Drop-offs and pick-ups are **by appointment only** between 9am-6pm. A fee of \$25 will be applied if Owner arrives outside of normal business hours.

Payment is due upon drop off via credit/debit card, cash, or check. Returned checks are subject to a \$20 fee added to the owner's balance. Unpaid balances may incur late fees of \$10 per day.

If Owner's female dog comes into heat during their stay, a \$25 per day fee will be added to cover the additional cleaning & care required. Balance is due upon pick up.

2. Health & Vaccination Requirements

Owner certifies that their dog(s) is/are in good health, free of fleas/parasites, and current on all required vaccinations, including:

- Rabies
- Distemper/Parvo (DHPP)
- Bordetella (Kennel Cough)

Owner agrees to provide valid proof of vaccinations at least two days prior to boarding reservation. Vaccines must have been administered by a vet clinic. Home administered vaccines will not be accepted.

If Owner's dog(s) will need to be given any medication during their stay, a Medication Permission Form must be filled out and turned in at check-in.

3. Emergency Veterinary Care

If the dog becomes ill or injured, the Facility will contact the Owner to notify of the situation. The Facility is authorized to seek veterinary care at the nearest vet office or emergency vet clinic. The dog's well-being will always be the top priority.

4. Behavior & Safety

Owner certifies that their dog(s) have never bitten a person nor shown aggressive behavior towards humans. Facility reserves the right to refuse service to dogs displaying dangerous or aggressive behavior.

A trial night is required before each dog is approved for boarding reservations. Determining the success of trial nights is up to the Facility and will always be based upon what is best for the dog.

Dogs must be on leash while entering and exiting the Facility.

If dogs of the same household share a boarding suite, the Owner deems the dogs able to share toys, bedding, and food without incident. The Facility will not be held responsible for injury caused by shared suites.

Owner is responsible for any property damage or injury caused by their dog(s).

5. Personal Items & Food

Owner may provide items such as bedding, toys, leashes, etc.
Facility is **not responsible** for lost or damaged personal items.

Dog food is to be provided by the Owner. If the dog(s) runs out of food during their stay or Owner forgets to bring food, dog(s) will be fed Orijen Amazing Grains Original dry food for \$3 per meal per dog during their stay. Charges are due upon pick-up.

6. Abandoned Pet Policy

If the Owner fails to pick up the dog within **3 days** of the scheduled check-out date and no communication or payment arrangements are made, the dog may be rehomed or surrendered to a local shelter as permitted by law.

Owner remains responsible for all outstanding boarding fees.

7. Liability Waiver

Owner agrees that the Facility, its employees, and agents are not liable for:

- Illness, injury, or death resulting from preexisting conditions or advanced age
- Illness due to exposure before arrival
- Accidental injury during normal play
- Loss of personal items

Owner releases the Facility from all liability except in cases of gross negligence or willful misconduct.
