Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to One Point Healthcare via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;
One Point Healthcare , we or us	One Point Healthcare, a company incorporated in England and Wales with registered number whose registered office is at 2, Andrews close, Middlx, HA1 3GE;
UK and EU Cookie Law	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011 & the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2018;
User or you	any third party that accesses the Website and is not either (i) employed by One Point Healthcare and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to One Point Healthcare and accessing the Website in connection with the provision of such services; and

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of One Point Healthcare and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, One Point Healthcare is the "data controller". This means that One Point Healthcare determines the purposes for which, and the manner in which, your Data is processed.

Data collected

How we collect Data

Data that is given to us by you

- 7. One Point Healthcare will collect your Data in a number of ways, for example:
 - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - **b.** when you make payments to us, through this Website or otherwise;
 - **c.** when you use our services;

in each case, in accordance with this privacy policy.

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - **a.** we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Who we share Data with

- 11. We may share your Data with the following groups of people for the following reasons:
 - a. relevant authorities if needs due to Patient medical condition, any disclosures which could be harmful for the person him/herself or to the wider society. Also needs to be informed if necessary to person's GP;
 - b. GP surgery medical.
 - c. Police, Social services, other charities, to prevent crime and abuse patient and community safety.

in each case, in accordance with this privacy policy.

Keeping Data secure

- 12. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
- 13. We are certified to ISO 27001. This family of standards helps us manage your Data and keep it secure.

Data retention

Your rights

- 18. You have the following rights in relation to your Data:
