Motion for Summary Judgement, Injunctive & Monetary Relief

NOW COMES the plaintiff, Thomas C. Fernandez, Pro Se, and as their Motion for Summary Judgment with Injunctive and Monetary Relief, states as follows:

Motion for Summary Judgment

Due to the all-encompassing medical malpractice on the defendant's part, including causing the plaintiff's divorce, and per Illinois legislation, Plaintiff moves for summary judgment with relief.

Injunctive Relief Sought

The plaintiff requests two injunctions.

First: That the court should impose an immediate order against the defendant, in the form of restraints on their marketing, promotional, internet advertising, or any other publicly available materials provided to patients, peers, suppliers and etc. The restraints must include prohibitions against using the words in any form of, "Christian Counseling", or "Mental Health", or any derivative of these statements.

If I do cause my patient's divorce, I will not try to blame them for it, and lie to their families, in an attempt to save my job, and my license.

I will not make derogatory statements towards my patients, while they are suffering from inappropriate weening from medication, which I refused to prescribe, like, 'be careful how you talk to your ex-wife'.

I will at all times LISTEN TO MY PATIENTS, and at all times assume that one day they will completely recover, because it's extremely expensive to assume otherwise."

Steve is free to sign this statement, every Monday, with either his official title and name, or if that's too embarrassing, he can sign it with "The Stevil Weasel". This statement must be rewritten, EVERY Monday, for the duration of his employment, in an attempt to impart some personal responsibility, ethical reminders, and moral balance.

Monetary Relief Sought

That the plaintiff seeks monetary relief in the form of reimbursement for damages incurred due to the defendant's actions, at an amount not less than 20% of damages and future liabilities incurred, with any and all attorney's and filing fees to be paid by the defendant. An affidavit of (financial) damages has been provided to this court.

Wherefore, Plaintiff requests that this honorable Court grants this motion for summary judgement with relief.
