Oh, and also teaching you a whole lot about professional liability, financial consequences, context and continuity of events, and what divorce does to a Catholic soul.

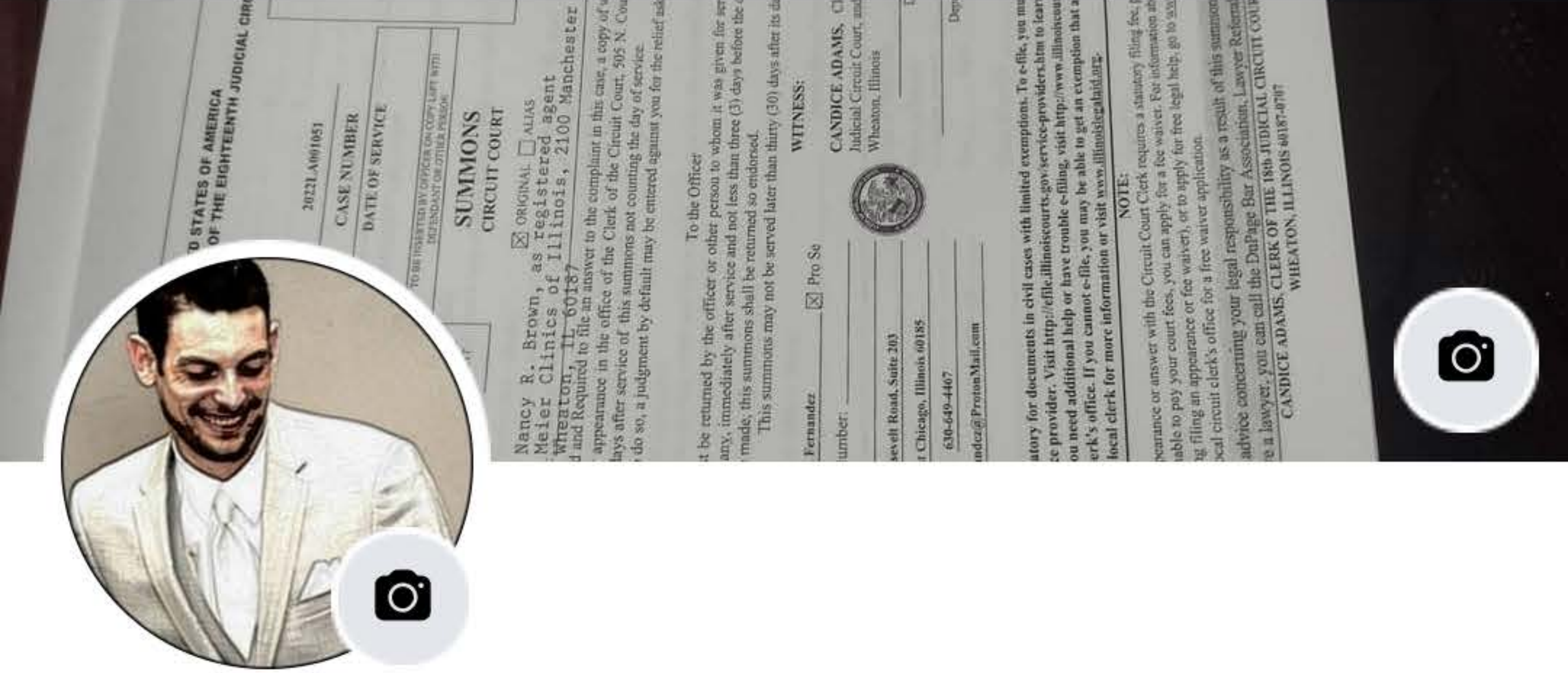

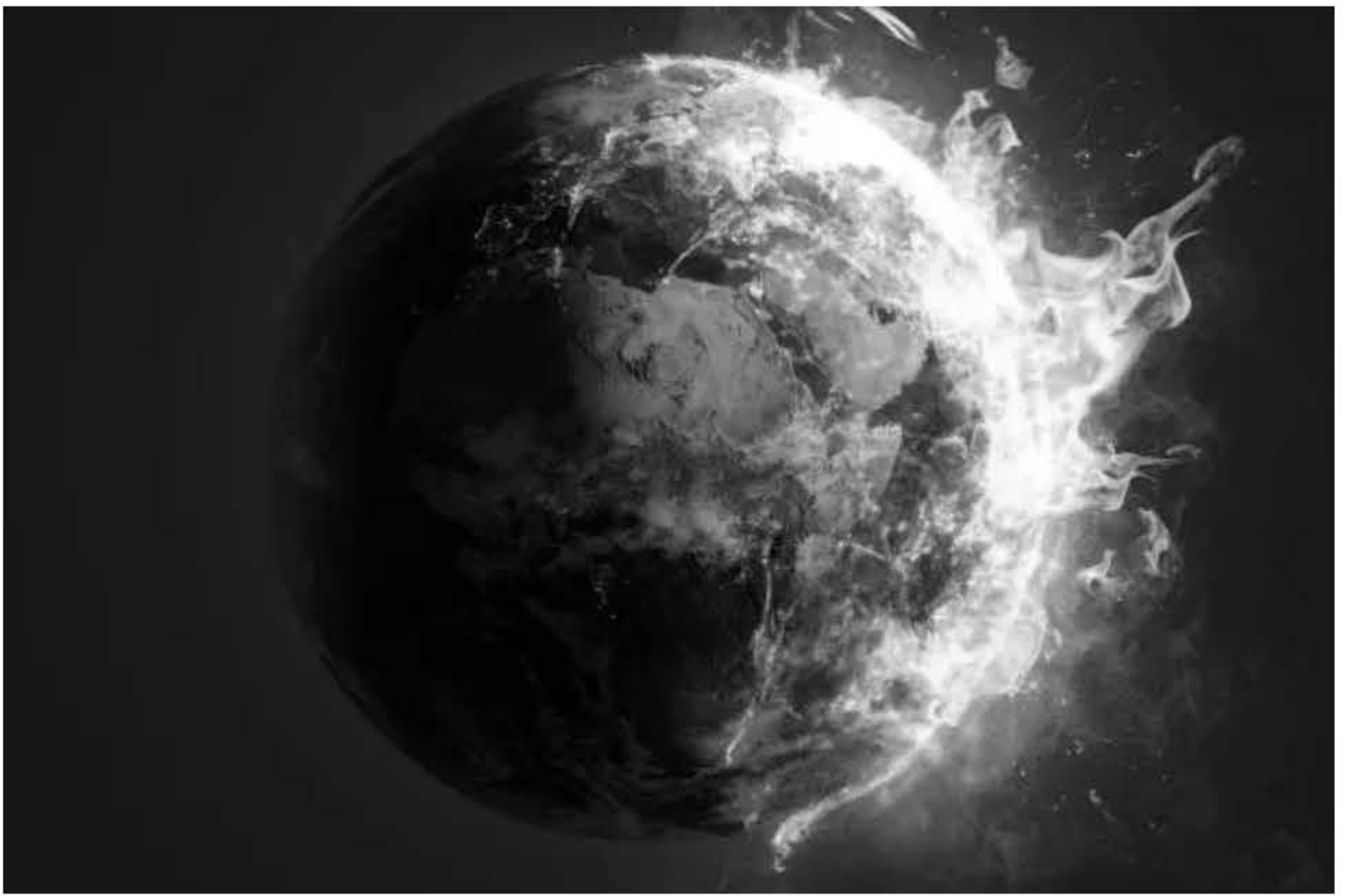
