## **DUES NOTIFICATION TO ALL IACT PROPERTY OWNERS:**

The IACT BOD voted for the 2025-2026 Dues to be set as \$1,656.00. The IACT BOD has approved the following options.

- **OPTION #1** One-time payment in the amount of \$1,656.00 due November 1, 2025 and must be paid by November 30, 2025. Payments received after November 30<sup>th</sup> will be considered delinquent and assessed interest charge of 5.0% each month until paid and membership cards will be de-activated.
- **OPTION #2** 4-payment plan installment (a processing fee of \$40.00 will be applied to this payment option which will make the total amount due to IACT \$1,696.00): Payment schedule is as follows:

<u>1st payment of \$424.00 due November 1, 2025</u>, payments received after November 30th will be considered delinquent and assessed interest charge of 5.0% each month until paid and membership cards will be de-activated.

**2**<sup>nd</sup> **payment of \$424.00 due January 1, 2026,** payment received after January 31<sup>st</sup> will be considered delinquent and assessed interest charge of 5.0% each month until paid and membership cards will be de-activated.

<u>3rd payment of \$424.00 due March 1, 2026,</u> payment received after March 31st will be considered delinquent and assessed interest charge of 5.0% each month until paid and membership cards will be de-activated.

4<sup>th</sup> payment of \$424.00 due May 1, 2026, payment received after May 31<sup>st</sup> will be considered delinquent and assessed interest charge of 5.0% each month until paid and membership cards will be de-activated.
