## **10 POINT HOARDING CHECKLIST**

For engineer /maintenance / property management /repair teams

#### 1. PRE-VISIT & LONE WORKING

Flag "hoarded environment" on the job.
Consider two-person attendance / daylight visit.
Confirm access route, parking, and lift/stair use.
Ensure RAMS covers hoarding, sharps, pests, biohazards.
2. DYNAMIC RISK ASSESSMENT ON ARRIVAL
Pause at the door: sight/smell check (smoke, gas, ammonia, damp, solvents).
Identify a clear exit route you can reach at all times.
Stop work if life-safety risks exist (e.g., gas smell, blocked only exit, structural instability, live electrics + water, aggressive pests).
3. PPE & HYGIENE CONTROLS
Minimum: safety boots, gloves, long sleeves; add FFP2/FFP3 mask, eye protection, disposable coveralls as needed.  Sharps awareness; carry grabber/tongs and a rigid sharps container if policy permits.  Hand hygiene and clean-down kit available.
4. ACCESS & EGRESS
Request/agree a clearpath from the entrance to the work area and to an exit.
Do not climb on stacks or move heavy piles without risk controls.
No hot works/ignition sources near combustible piles.

# **10 POINT HOARDING CHECKLIST**

### **5. UTILITIES & LIFE SAFETY CHECKS**

	Gas: smell/CO risk, ventilation, flue/vent blockages; isolate if unsafe.	
	Electrics: exposed wiring, overloaded multi-plugs, trailing leads under clutter; isolate if required.	
	Smoke/CO alarms present and functional (note if absent).	
	6. PREPARE A SAFE WORKING ZONE	
	Agree a temporary clear zone (~2 m²) around work area/appliance.	
	Bag/label items you move (with consent), place back after.	
	If the zone cannot be made, safely: abort and rebook with clearance support.

	7. BIOHAZARDS, PESTS & WASTE	
	Look for faeces, urine, vomit or other bodily fluids; exit property as safely	′
	as possible, and follow biohazard protocol  Look for needles, mould, infestations: exif propert as safely as possible	
	and follow biohazard protocol  If contact is made with any biohazards, it is important to follow company

	8. RESPECTFUL ENGAGEMENT & CONSENT	
	Use neutral language ("hard to access," "safety"), not judgment.	
	Explain what must move and why; get consent before handling possessions.	
	Record what was moved and where it was returned.

### 9. RECORDING, PHOTOS & ESCALATION

Document hazards, access limits, and works completed; use Clutter Image Rating (CIR) if your policy supports it.
Photos only if policy allows and with consent/justification.
Escalate to housing/TSO; consider Fire & Rescue Home Safety referral and safeguarding/self-neglect routes if children/vulnerable adults are present.
10. DECONTAMINATION & CLOSE-OUT
Doff PPE safely; clean tools/boots; bag contaminated disposables.
Leave access/egress as found or improved; confirm any isolations left in
place. Provide clear next steps (rebook with clearance, safety actions) and update the job system same day.

#### **!!!QUICK STOP TRIGGERS!!!**

Any gas smell/CO symptoms; only exit blocked; structural collapse risk; live electrics in water; aggressive pests; heavy mould/biohazard without controls. Do not proceed—make safe, isolate, and escalate.
