## MARTINS WOODS COMMUNITY ASSOCIATION MEETING MINUTES

#### SUNDAY, JULY 31, 2022

MEETING START TIME: 2:56PM

**MEETING GOAL:** Discuss plans for the future of Martins Woods community and establish board member leadership roles within the community association.

### **MEETING DETAILS:**

Before the official start of the meeting, attendees received copies of the meeting agenda and were asked to sign an attendance/contact information sheet, and participate in an icebreaker. The meeting began with opening remarks by Mr. Dwayne Stanton, and an outline of discussion topics were projected on a large screen. Below is a summary of the discussion:

- Mr. Stanton explained circumstances causing lapse in time since last community meeting and issued apology to community members/ announced Mr. Mark Applegate's (not in attendance) resignation from MWCA
- MWCA (Martin's Woods Community Association) should be an organization having a common interest

-Slogan for MWCA is "Neighbors helping neighbors"

-Community members expressed preference to have community association over HOA

-If some neighbors within Martins Woods want to Opt out of participating in MWCA, they cannot take advantage of benefits

-Need New Tax I.D maybe 501 (c) / (3) nonprofit organization? Need more information about qualifications for this type of nonprofit

-May need to consult local politicians for guidance/ resources/need lawyers in community to help/advise

-Need to setup bank account for MWCA (Mr. Keith Loughery will look into this further)\*
- Majority neighbor participation important because we want to be a strong, respectable community/ helps create broader reach among local political representatives

• MWCA website is up and running

-Website will continue to improve, especially with more community input/ suggestions/ participation

-Community members of Martins Woods are encouraged to use/ explore the community website and to inform other neighbors (who were not in attendance) to visit website as well -Community website should be used to communicate, pay community association dues, view community meeting information and upcoming events, share suggestions and concerns

- Need more neighbors to volunteer for leadership positions including: -COPS/ Community Oriented Policing Services (coffee club volunteer attendees): Coffee club meets with police officers to represent neighborhood and discuss community issues (For more information visit safety tab on MWCA website)/ two volunteers so far (need more)/1. Jean Holland 2. Keith Loughery -Block Captains: Representative from each block within Martins Woods that checks in with neighbors / two volunteers so far (need more)/ 1. Kari Muhammad 2. Sally Loughery -Committees (Hospitality, Communications, Utilities, Public Relations) -Hospitality: Provide refreshments for community meetings/events, organize fundraising/donations -Communications: Gathers important information to share with community/ "See something, say something, so someone can do something" / one volunteer so far (need more)/ 1. Ms. Audrey Johnson (able to volunteer on part-time basis) -Utilities: Neighborhood maintenance -Public Relations- Meet with public officials to discuss neighborhood concerns, point of contact for news outlets -Sergeant at Arms: Maintains peace within neighborhood/ will vote on during next community meeting/one volunteer: Danny Basile • Contact information shared at meeting with MWCA is private -Contact information will only be available on need to know basis -Please do not share other neighbor's personal information, instead, please refer neighbors to MWCA website (www.martinswoods.org) for guidance/help/ more information/ ways to participate How should we meet in the future? / how often? -New Carrollton Library/ pricey, time and space constraints -Need more meeting place ideas -Should we meet every other week/ quarterly/ virtual/in-person/ monthly/mix of all? -If something happens we can arrange meeting to discuss issues -Meeting attendees requested to revisit these questions later in the meeting/ also noted that quarterly meetings might be a better way to stay in touch -Follow-up meeting in a month? Maybe end of August? Before/ after Labor Day? -Meeting attendees agreed they prefer to decide date of next community meeting, after Labor Day holiday Cpl. U. Jones -Police officer who is point of contact for neighborhood
  - -Cpl. Jones business/contact cards provided at meeting
  - -Need her guidance when seeking information about permits
  - -Very responsive and helpful/ proactive

-Valuable to have law enforcement help

-Need to inform residents when it is appropriate to call police/emergency services (crime in progress/injury), then MWCA will discuss how issue occurred/ preventive solutions

Noise issues

-Meeting attendees voiced concerns about loud music in late hours in Martins Woods and New Carrollton

-Need to discuss with Cpl. Jones our concerns about noise/ jurisdiction noise -Is there existing ordinance in New Carrollton?

-Cut-off time for music? Meeting attendees agreed cut-off time for music is needed/ noise has changed/possible to address between neighbors?

-Do not approach residence personally, please call authorities and they will handle concerns (residents can contact Cpl. Jones)\*\*

Who should be included in MWCA?
 -Should homes located on Riverdale Rd., adjacent to Martins Woods neighborhood, be invited to participate in MWCA?

-Attendees voted "yes" in the affirmative

-Need to consult county records

-Should homes in Martina Terrace be invited to participate in MWCA? / need to research if Martina Terrace is part of Martins Woods?

- Community members should pay attention to things that seem odd in neighborhood/ may help other neighbors in need of assistance
- Speed bumps/ cameras needed throughout neighborhood?
   -Would speed bump/ camera installation throughout neighborhood slow motorists down?
   -Motorists traveling through neighborhood are not obeying STOP signs
   -Need to research who we should notify about issue and ask about additional efforts to enforce speed limits
- Parking issues

-Hard to turn into neighborhood because of parked cars on corners/ people parking too close to stop signs

-People who are not residents of Martins Woods park vehicles in neighborhood to sell or to catch bus

-Cars belonging to non-Martins Woods residents park in front of homes in neighborhood and perform pickup/drop off with school buses / how was this arranged? Were Martins Woods residents notified?

- New sidewalk installation along Riverdale Rd. provides safer passage for pedestrians to Metro
- Will Riverdale Rd. be repaved? Roadwork/ inclement weather etc. cause potholes and uneven pavement to form
- Maglev train concerns

-Will increase dump truck transit nearby

-Will remove green spaces

-Residents in surrounding areas may experience vibrations

-Not beneficial for PG County residents

-Devastating health, economical, and environmental impacts

-Home values may suffer/ decreased property value

-Need to create better awareness surrounding this issue

-Will try to approach more representatives about our concerns/ public officials may be able to better advise us on best approach

- Garbage pickup issues:

   Need better garbage collection/garbage is dropped in street/sloppy pickup/foul smell/ broken glass/trucks drive too fast
   Please email or dial 311 to report garbage collection issues/ take a picture of issue to include with report
   Can also directly report garbage issues to Bates Trucking Trash Removal Inc.
   Reports encourage inspectors to come out and investigate issues
- Are community members interested in having a Block Party?
   -Maybe during September?
   -Meeting attendees voted "no" to host Block Party in September 2022/ too soon/ need more time to prepare/but want to revisit topic in future for spring 2023
- Bus Stop Concerns:
   -Some residents have been experiencing disturbances by adolescents at nearby bus stop
   -Need to find out best way to report/ prevent disturbances
- Vote on MWCA board positions

-During the meeting, community members voted unanimously (32-0) to elect the following community members to board roles

-President: Mr. Dwayne Stanton

-Vice President/Vice President of Communications (community members also voted to combine these roles): Mr. Lonnie Dawkins

-Secretary: Ms. Jessica Holland

-Treasurer: Mr. Keith Loughery\*

- Should dues be collected online? Possible methods of payment include:
  - -Zelle

-Cash App

-Personal check

Big Trucks Concern

-Tags on trucks are personal not commercial

-Take pictures of large commercial vehicles believed to be in violation/obstructing flow of traffic and send to 311

-New Carrollton has signs posted throughout neighborhoods prohibiting commercial vehicles -Need signage prohibiting commercial vehicle parking in Martins Woods?

- Trespassing concerns
   -Some neighbors have had people trespassing through their yard/ taking a shortcut from Martins Terrace
- Senior home/ Assisted Living concerns
   -Need to find out what types of businesses are/not permitted
- When is the best time to host future meetings?
   -Community members collectively stated that Sunday's around same time as current meeting (2:45pm-4:45pm) was best
- At the conclusion of the meeting, meeting attendees introduced themselves by name and street/gift card prize was presented to one community member
