MCL LIFE TIME MEMBERSHIP FEES

The National Board of Trustees met on 19 April 2023 to discuss the Marine Corps League's Life Membership Fees. In the year 2004, it was the last time that Life Membership Fees were increased at the National Conven-

"Section 7050. Life Members. ... Effective 1 September 2021 the Life Membership fee shall be as established by the National Board of Trustees and shall be posted on the National Website."

The National Board of Trustees has the fiduciary responsibility for the operation and budget requirements of the Marine Corps League. After full discussions and considerations, the National Board of Trustees voted and approved. Effective 1 July 2023, the Life Membership Fees will increase as per the following chart:

\$1000.00 – less than 35 years of age

\$ 400.00 – 65-84 years of age

\$ 800.00 – 36-50 years of age

\$ 100.00 – 85 years and older

\$ 600.00 - 51-64 years of age

The above Fees are only available if the member's annual dues have been paid and the member is in good standing. Any member desiring to pay their Life Membership Fees at the current rate, must do so and be post-marked no later than 30 June 2023. Any Life Membership payments after that date are listed above.

40.03 Officer Tenure/Succession

(c) All Elective Department Officers may succeed themselves through re-election to respective offices, however, the Department Commandant may succeed himself for only (1) additional term, thereafter he may be eligible only as herein above provided.

PROPOSED

(c) All Elective Department Officers may succeed themselves through re- election to respective offices, however, The Department Commandant may succeed THEM-SELVES for only one (1) AND PAYMASTER MAY SUCCEED THEMSELVES FOR ONLY FOUR additional terms, thereafter they may be eligible only as herein above provided.

WHAT OPTIONS ARE AVAILABLE TO LOG IN TO VA.GOV?



Veterans can handle many VA tasks online. You can create and use a free account to sign in to VA.gov, where you can view your health care and benefit statuses and handle tasks like uploading forms online to VA. You have several options to choose from when creating or logging in to an online account on

VA.gov. VA recommends you use Login.gov.

WHAT'S MULTIFACTOR AUTHENTICATION AND WHY DOES **VA.GOV USE IT?**

Multifactor authentication is an extra layer of protection on your account. It ensures it's actually you trying to access your account—and not a hacker. It's also sometimes called two-factor authentication.

Each time you sign into a VA website or app, you'll use multifactor authentication to verify you're you. You'll do this using a device that only you should have access to, such as your mobile phone.

You'll get a unique code by text message or phone call, or through another option you choose like Google Authenticator, a security key, or backup codes. You'll then enter that code to access your account.

This way, even if someone were to guess or steal your username and password, multifactor authentication can stop them from accessing your account.

HOW DO I FILE A TRAVEL REIMBURSEMENT CLAIM ONLINE AND GET MORE INFORMATION?

VA travel pay reimbursement pays eligible Veterans and caregivers back for mileage and other travel expenses to and from approved health care appointments. Find out if you're eligible and

how to file a claim on the VA Travel Pay Reimbursement webpage.

IS THERE AN OFFICIAL ALL-IN-ONE MOBILE APP THAT I CAN USE TO CONNECT ME WITH VA HEALTH CARE AND BENEFITS SERVICES RIGHT FROM MY MOBILE PHONE?

Yes! With the official VA Health and Benefits mobile app, you can manage your VA health care, benefits and payments from your mobile phone or tablet. Using your mobile device anywhere, anytime, you can quickly and easily:

View and cancel your health care appointments

View, track and refill VA-dispensed prescriptions

Send and receive secure messages with providers

Check on your VA claims and appeals

Upload supporting documents

Get your VA vaccine records

Review history of payments received from VA

Access the Veterans Crisis Line

In addition, VA is continually adding new features to the mobile app.

Don't have the VA Health and Benefits mobile app yet? Getting it is free, fast and easy! Just go to the Apple or Google App Store or wherever you usually get your mobile apps. Search "VA: Health and Benefits." Follow directions to install the app on your mobile device and sign in as you normally do, or create a Login.gov account.

Emergency Medical Care Coverage



What to know if you get care outside of VA. A Veteran and his/her doctor discussing his medical care

If you're experiencing a medical emergency, you shouldn't hesitate to get emergency care. Call 911 or go to the nearest emergency room quickly. A medical emergency is an injury, illness, or symptom so severe that without immediate treatment, you believe your life or health is in danger.

Some Veterans live far away from a VA emergency room and need to get care quickly. If you go to a non-VA emergency department for care, VA may still offer coverage.

Notifying VA is necessary for getting coverage and sharing important medical updates. We have the information you need to make it happen.

Notify VA as soon as possible

During a medical or mental health emergency, we encourage you to seek immediate medical attention right away. You don't need to check with VA before calling 911 or going to an emergency department. But it's important that the facility treating you notifies VA within 72 hours.

Promptly notifying VA allows them to coordinate care or transfer to a VA medical facility, if necessary. It helps VA check if the requirements for them to pay for the care are met and may impact a Veteran's eligibility for coverage.

Payment by VA is limited to the time of stabilization, except when:

VA is contacted upon stabilization but can't accept the transfer of the Veteran, and

The community care facility made and documented reasonable attempts to transfer the Veteran to a VA or other facility.

How to notify VA

It's best to ask your emergency care provider to report the treatment to VA's Centralized Emergency Care Reporting Center as soon as possible. If you're able, tell your care provider that you're a Veteran. It's a good idea to remind caregivers and other family who might be with you in an emergency that they should tell a care provider your Veteran status.

Your emergency care provider should report the treatment using the VA Emergency Care Reporting portal or by calling 844-724-7842.

Be prepared

If you live in an area where you may need to seek health care outside of VA, prepare before you go. Locate your closest emergency department so that you don't have to worry about that during an emergency.

You can also plan by locating your nearest urgent care facility. Urgent care is different from emergency care. Urgent care services are for less than life-threatening illnesses or injuries, like strep throat or pink eye. Save yourself time later by keeping a handy list of the urgent care clinics closest to you. Find out in advance which ones are in-network with VA.

Remember: If you're seeking emergency services, you don't need to check with VA before calling 911 or going to an emergency room. Getting care when you need it is the priority.

Be sure to keep your emergency contact information up to date in My HealtheVet. Log a name, contact method, and phone number for people who should be contacted in case of emergency. This tool is for your records only—your VA health care team won't see it unless you share it with them.
