#### MARINE CORPS LICENSE PLATES



One must provide a legible copy of a DD214 (discharge from military service) or a letter of verification from the Illinois Department of Veterans' Affairs or the fed-



eral government or a current DD Form 2 (U.S. Uniformed Service Identification Card) verifying service record.

The request can only be processed in Springfield. Apply in person or mail the proper documentation to:

or Local Drivers License Facility, State website is to be updated in the near future


#### **Availability**

Marine Corps License Plates may be issued to any Illinois resident who served in the United States Marine Corps. Proceeds from this plate go into the Marine Corps Scholarship Fund, to be used for scholarships for undergraduate, graduate, and career and technical education and certification, financial assistance, or monetary awards to veterans or veterans' families that are located within the State of Illinois.

Public Act 625 ILCS 5/3-506

Marine Corps license plates are multi-year and may be displayed on motorcycles, passenger vehicles, trucks and vans weighing 8,000 pounds or less and sport utility vehicles.

#### Did you know...

#### THE MARINES FIRST WON FAME FOR FIGHTING PIRATES.

Following a brief disbandment after the American Revolution, the Marine Corps was revived in July 1798 and later sent into action against the Barbary pirates, a group of North African corsairs that had spent years raiding American merchant shipping and extorting costly ransoms and tributes. In 1805, Lieutenant Presley O'Bannon and a small contingent of Marines arrived in Egypt and assisted American naval agent William Eaton in assembling a mercenary army to overthrow the Barbary ruler of Tripoli. They then took their soldiers-for-hire on a grueling 50-day march across the desert to Derna in modern day Libya. With the help of a bombardment of U.S. Navy ships, the Marines participated in a daring assault on April 27 that successfully seized the city and its fortifications. The victory was the first ever battle fought by the United States on foreign soil, and helped lead to a favorable peace deal in the First Barbary War. The Derna campaign has since been enshrined in the Marines' Hymn with the famous line "to the shores of Tripoli."

#### WHERE DID THE MARINES GET THE NICKNAME DEVIL DOG?

German soldiers nicknamed Marines "Teufel Hunden," or "Devil Dogs," after their heroic fighting on the battlefields of France in 1918. According to military lore, Marines were ordered to fight their way up a hill during the Battle of Belleau Wood of World War I while wearing gas masks, which made them sweat and turned their eyes bloodshot red. The Germans saw these figures clambering upward on four legs and thought they looked like the fierce mountain dogs from Bavarian folk stories.

#### THE MEANING OF 'OORAH' TRACED BACK TO ITS ROOTS

Marines and historians have determined the true origins of "Oorah" lie with recon Marines stationed in Korea in 1953. During this time, reconnaissance Marines in the 1st Amphibious Reconnaissance Co., found themselves traveling via submarine to where they were needed. The memorable call of "dive, dive!" would be called on the intercom and a klaxon alarm, which made a very distinct "Aarugha" sound, would announce the descent of the sub below water.

The recon Marines, who heard this sound often, started using it as a motivational tool during runs and physical training. Over time, the word "Aarugha" came to be too much of a mouthful, and eventually molded itself into the familiar "Oorah," according to Maj. Gary Marte, a retired Marine.

Confirmation for this version of the story rests with the official Marine Corps Training Reference Manual on the history of Marine recon, titled "Aarugha," the manual gives credence on the origination of the phrase with reconnaissance Marines. "Oorah" is just one of the things that separates Marines from any other branch of service, and has become a part of our lasting history.


