Data Center proposed for Coweta

Excerpts from the Broken Arrow Sentinel article on 10/28/2025. "Beale Infrastructure, the company proposing to build a large data center in Coweta, said Monday it is evaluating plans to use water from the Verdigris and Arkansas rivers and the site could consume as much as 400 megawatts of electricity annually. The primary driver of water use is the cooling system to be used for the data center, and that is still under evaluation. For industrial water, Beale is working with City of Coweta and RWD5 on studies to source water from the Verdigris and Arkansas Rivers. The zoning application proposes a maximum noise limit of 65 decibels." The entire article is linked below.
