PSO 2021 Winter Storm Bonds Challenge

OKLAHOMA CITY – An appeal brief filed Thursday by Rep. Tom Gann, R-Inola, asks the Oklahoma Supreme Court to invalidate some \$700 million in ratepayer-backed bonds issued to cover costs incurred by Public Service Company of Oklahoma (PSO) during February 2021's Winter Storm Uri. Payments for those bonds have been collected on the monthly bills of PSO's customers since the bonds were issued in September 2022. They are scheduled to continue for another 17 years.




The family's lawsuit claims deputies used excessive force when arresting Krueger or failed to intervene when necessary for his health, violating his 4th amendment rights. The opinion released by the United States Court of Appeals For the 10th Circuit asserted, "Ultimately, we conclude that although the district court's recitation of the facts was incomplete and, in some instances, not stated in the light most favorable to the Estate, the court reached the correct conclusion: Defendants are not entitled to qualified immunity. We therefore affirm the district court's denials of summary."

"Body camera footage of the incident blatantly contradicts this factual finding. As detailed in the fact section below, the video reveals that for long portions of the encounter, Mr. Krueger was exhausted, not fighting back, and under the control of the Deputies."

PERSICA SOLAR, LLC

Persica submitted an Application for Conditional Use Permit to Wagoner MAPC in September 2024. The solar farm project is to be located south of Porter, OK, stated to produce up to 241.7 megawatts of photovoltaic solar energy with a capital investment of \$336 Million. Reported to be 4500 acres.

Resident opposition resulted in several public meetings. On June 16, 2025, 2 of the 3 county commissioners voted to deny the solar farm application. On June 26, 2025, Persica Solar, LLC filed a Petition for Judicial Review. Here is the first page of the petition. You can find the entire document in the Litigations section of our website.


