

# **Athlete/Staff Requirements and the Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow players, parents, and staff to be at the practice facilities. Parents and spectators wishing to watch may do so from a distance 15' away from courtside. Fabric facemasks are strongly recommended when social distancing cannot be maintained

Furthermore, all athletes, parents, and staff of SI Wave must agree to and abide by the following:

- IF YOU OR SOMEONE IN YOUR HOUSEHOLD HAVE EXPERIENCED ANY OF THE FOLLOWING SYMPTOMS IN THE PAST 14 DAYS, YOU WILL NOT BE PERMITTED TO PARTICIPATE IN THIS EVENT.
- Fever of 100.4 or greater in the past 14 days
- New Cough
- Shortness of breath or difficulty breathing
- Chills
- Sore Throat
- Body Aches
- Loss of Sense of Smell or Taste

SI Wave has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19; however, we cannot guarantee that you, your child(ren), and spectator/friends will not become infected with COVID-19. Further, attending club events could increase your risk, your child(ren)'s risk, and your spectator friends risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending club events, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. By signing this agreement I am also acknowledging that I am healthy, and am not experiencing any of the above symptoms, nor have I been knowingly around anyone who may have been diagnosed or quarantined for COVID-19 in the past 14 days. By signing this agreement I agree to disclose all symptoms listed above and consent to a temperature check prior to any club event.

I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, SI Wave employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at this event or participation in SI Wave programming ("Claims").

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless SI Wave, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any claims based on the actions, omissions, or negligence of SI Wave, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SI Wave activity.
