

STOP THE HIGHWAY 101 ROCK QUARRY

AT THE PAULDING / CARROLL COUNTY LINE

- Heavy Truck traffic on primary and secondary roads in Paulding and Carroll Counties will affect all citizens of both counties.
- Blasting which can damage home foundations.
- Invisible silica dust which can cause health issues for both humans, livestock, and wildlife, as well as make hay harvesting no longer possible as silica dust makes hay unsuitable for livestock to consume. Dust can travel 5 miles.
- The quarry will bring increased noise, air pollution, and heavy commercial truck traffic; it will also negatively impact nearby property owners' quality of life, have far-reaching damage to homes from vibration/tremors caused by the blasting at the quarry, and have a negative impact on the local environment.
- Truck traffic is estimated by the quarry applicant to be 218 trucks per day. 109 trucks in and 109 trucks out of the facility on Highway 101 with 60% of the traffic travelling south on Highway 101 to I-20 through Villa Rica and the other 40% traveling north on Highway 101 and beyond.
- Wildlife will move out of the area and be replaced by the sound of trucks, crushers, blasting, and the view of the silos and conveyors instead of the pastoral setting we enjoy today!
- Wells, ponds, springs, creeks used by many of our residents will likely be negatively impacted. Water table will drop as the quarry blasts deeper and these water sources can go dry as a result.
