- I agree to hold harmless Mindy Wideman, Falconwood Farms, and any associate of any injury me, my child, or any visitors I bring to the farm.

Release of Liability

This RELEASE of LIABILITY is made and entered into on this _____ day of _____, 20 _____, by and between Mindy Wideman, hereinafter designated MANAGER and _____ hereinafter designated RIDER, and if Rider is a minor, Rider's parent or guardian, _____. In return for the use, today and on all future dates of the property, facilities and services of the Manager, the Rider, his heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. It is the responsibility of the Parent/Guardian to carry full and complete insurance coverage on his child, personal property and himself.
2. Parent agrees to assume ANY AND ALL RISKS INVOLVED IN OR ARISING FROM THE RIDER'S USE OF OR PRESENCE UPON MANAGER'S PROPERTY AND FACILITIES including, without limitation but not limited to, the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
3. Rider and parents agrees to hold Manager and all of its successors, assigns, subsidiaries, affiliates, officers, directors, employees and agents completely harmless and not liable and release them from all liability whatsoever and AGREES NOT TO SUE them on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of Rider's use of or presence upon Manager's property and facilities, including without limitation, those based on death, bodily injury, property damage, including consequential damages.
4. Rider and Parents agrees to indemnify and defend Manager and property owners against, and hold it harmless from, any and all claims, causes of action, damages, judgments, costs or expenses, including attorney's fees, which in any way arise from the Rider's use of or presence upon the Manager's property and facilities.
5. Rider agrees to abide by all of Manager's rules and regulations.
6. If the rider is using his horse, the horse shall be free from infection, contagious or transmissible disease. Manager reserves the right to refuse horse if not in proper health or is deemed dangerous or undesirable.
7. Photo Release - I agree to grant to Falconwood Farm Riders and its authorized representatives' permission to record on photography film and/or video, pictures of my child's participation. I further agree that any or all of the material photographed may be used, in any form, as part of any future publications, brochure, or other printed materials used to promote Falconwood Farm Riders, and further that such use shall be without payment of fees, royalties, special credit or other compensation.
