- Positively support all your teammates at practice and in competition
- Respect all members of FTC (athletes, coaches, officials and staff) and respect all members from the other clubs as well
- Ensure that when I leave an area (practice or meet) I leave it cleaner than when I arrived
- Remember "school goes first" and to keep my grades up,
- Be honest at all times
- Not use foul language
