OLD BUSINESS

Ms. McCleary moved to accept the September 2, 2025 meeting minutes; seconded by Mr. Ballinger.

Resolution for phase 2 of property cleanup at 383 Carolyn Dr.

RESOLUTION NO. 2025-10.07

FURTHER REMOVAL OF NUISANCE AT 383 CAROLYN DR., MARION, OH.

IN THE MATTER OF A RESOLUTION to provide for the further removal of solid waste, wood, tree trunks, wooden planks, limbs, woodworking equipment, temporary tarped shelter and other debris by homeowner Robert E. Bishop, located at 383 Carolyn Drive, Marion, Ohio 43302 pursuant to O.R.C. 505.87.

WHEREAS: Ohio Revised Code (ORC) 505.87 specifically vests Marion Township Board of Trustees with statutory authority to provide for the abatement, control, or removal of vegetation, garbage, refuse, equipment and other debris from land in the township, if the board determines that the owner's maintenance of that vegetation, garbage, refuse, equipment or other debris constitutes a nuisance.

WHEREAS: The Marion Township Trustees have determined the property located at 383 Carolyn Drive, Marion, Ohio continues to be a nuisance as defined by R.C. 505.87. The homeowner, Robert E. Bishop was notified on October 8th, 2025, to abate and remove all tree logs, limbs, split wood, wooden planks and other debris including wood saws, woodworking equipment, log splitter and as well as any temporary tarped shelter from the front and side yards of said property within seven (7) days. Homeowner shall not block access by chaining tree trunks to a trailer or prevent access by failing to remove a vehicle blocking a driveway. The Marion Township Trustees will employ a contractor(s) who will remove all the above if the homeowner, Robert E. Bishop fails to abate the property within the next seven days.

NOW, THEREFORE BE IT RESOLVED that this Resolution shall be immediately posted at 383 Carolyn Drive, Marion, Ohio 43302 and after the 7th day of posting the Marion Township trustees shall cause the nuisance (all tree logs, limbs, split wood, wooden planks and other debris including wood saws, woodworking equipment, log splitter as well as any temporary tarped shelter from the front and side yards of said property) to be abated with all costs for the abatement being certified to the property tax duplicate for the above referenced address. Said homeowner, Robert E. Bishop shall cease and desist continued collection of same nuisance property following this abatement and failure to do so may be dealt with through further legal action.

THE AFORESAID matter came before the Board of Marion Township Trustees on October 7th, 2025, at a regularly scheduled Board of Trustee meeting.

Mrs. McCleary made a motion to approve the resolution; seconded by Mr. Creasap.

Roll call as follows: Mrs. McCleary, yes; Mr. Creasap, yes; Mr. Ballinger, yes. Motion carried.

THEREFORE, BE IT RESOLVED that the Board of Trustees of Marion Township approved this resolution to be effective October 7th, 2025.

Ms. McCleary made a motion to accept the resignation of James Herring. Seconded by Mr. Creasap. Motion carried. Mr. Herring's last day worked was October 3, 2025.

Chief Meddles reported that the fire department has been awarded a FEMA grant in the amount of \$167,160.00. The township's portion is \$7,260.00. Motion made by Ms. McCleary to accept the award of a FEMA grant in the amount of \$167,160.00 with the township's cost of \$7,260.00; seconded by Mr. Ballinger. Motion carried.

Chief Meddles is asking for approval to sell truck 330 on Gov Deals. Motion made by Mr. Ballinger to approve the selling of truck 330; seconded by Ms. McCleary. Motion carried.

Chief Meddles reported that he attended a 2-day class on recruitment and retention. Marion Township is not the only entity having problems keeping employees.

Chief Meddles provided a quote for exterminating services for 2026 from Dave Dilsaver who has started his own business called DMDIL Enterprises. His quote for providing exterminating services on an annually is \$2,160. Mr. Creasap made a motion to accept the proposed quote from DMDIL for exterminating services for 2026 at a cost of \$2,160.00; motion seconded by Mr. Ballinger. Motion carried.

RESOLUTION 2025-0930

RESOLUTION ADOPTING A CYBERSECURITY POLICY

WHEREAS, the State of Ohio has implemented Ohio Revised Code §9.64, enacted in HB 96 (136th G.A.), requiring all local governments and jurisdictions to establish a cybersecurity policy by September 30, 2025; and

WHEREAS, the purpose of this requirement is to strengthen protections of public data, information systems, and technology resources from cybersecurity threats and risks; and

WHEREAS, the Marion Township recognizes the importance of safeguarding sensitive and confidential information entrusted to Marion Township; and

WHEREAS, a draft Cybersecurity Policy has been prepared and reviewed by staff and is

recommended for adoption as a framework for compliance with Ohio Revised Code §9.64 and HB 96; and

WHEREAS, the policy provides guidance on access control, system security, data protection, incident response, training, and vendor management, while requiring consultation with IT professionals and legal counsel for implementation and customization;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Marion Township, Marion County, Ohio, that:

- The attached Cybersecurity Policy is hereby adopted as the official policy of Marion Township.
- 2. This policy shall take effect immediately, with adoption required by September 30, 2025, and implementation of technical and training requirements no later than June 30, 2026, as provided by the Ohio Auditor of State.
- 3. The Board of Trustees shall distribute the adopted policy to all township departments, employees, and relevant contractors, and to ensure compliance in partnership with IT providers and legal counsel.
- 4. This resolution shall be in full force and effect upon its passage and adoption by the Marion Township Board of Trustees.
