Minimum qualifications include 18 years of age, high school diploma or GED, Ohio Firefighter Level II certification, valid Ohio driver's license, and State of Ohio Paramedic Certification.

Desired qualifications include Hazmat Operations level certification, ACLS, & PALS, but not required.

Applicants will be required to complete a criminal background check, driver's license review, personal background investigation, drug test and OP&FPF physical. Prior to appointment applicant will have to show proof of the <u>Tri-C Firefighter Physical Agility Testing or CPAT</u> (Candidate Physical Ability Test) taken within the last 12 months. The cost of the exam is the responsibility of the candidate.
