OLD BUSINESS

Mr. Dietrich reported on the Lusch Addition drainage project. The project has been completed by the county. Trent McDaniel will be installing another catch basin on the south side of Oakdale Dr. This will complete the Lusch Addition project.

Mr. Dietrich also reported on the Forest Hill Drive drainage project. An estimate was received from Mark Pickens for \$245,880.00 for replacement of storm tile on both sides of Forest Hill Dr. The township will put this project out for bid at the next meeting.

Mr. Dietrich reported he is still waiting to hear when Shelly & Sands will start the 2024 road paving project.

Mark McCleary reported that the township hall has yet another bird infestation/roof repairs. R&C Cooper are in the process of replacing the roof and ceiling tiles because of this.

Problem properties addressed by Marion County Prosecutor's office – Mark McCleary provided a listing of problem properties to the Board for their review.

Ms. McCleary reported that she spoke to someone from Frontier regarding the fiber optic cable installation and complaints from township residents.

NEW BUSINESS

Mr. Dietrich reported that there are storm water issues on Laura Dr. and Western Heights subdivision. Mr. Dietrich's recommendation is that we TV the area and find out where the problem lies. His map shows these areas have risers but he said there are none there. Roger estimates this project would cost approximately \$800 for Laura Dr. and \$6,000 for Western heights. Ms. McCleary made a motion to proceed with making repairs to these areas; seconded by Mr. Ballinger. Motion carried.

Chief Meddles reported he received an estimate for replacing lights at both fire stations. The estimate from Owens Electric is \$2453.00. Ms. McCleary made a motion to proceed with replacement of these lights; seconded by Mr. Creasap. Motion carried.
