The Board of Trustees of Marion Township, Marion County, Ohio met in a regular meeting. Mr. Ballinger called the meeting to order 5:30 pm with the following members and visitors present:

**PUBLIC COMMENT:** Tim Mooney was in attendance to introduce himself as a candidate for county commissioner.

Ms. McCleary made a motion to approve the minutes of the February 6, 2024 meeting. Mr. Creasap seconded the motion. Motion carried.

The fiscal officer reported the correspondence about MORE grant. The amount of the MORE grant is being increased from \$500 to \$1000.

# **OLD BUSINESS**

Mr. Creasap reported that he visited the area of Dee Mackall's residence and also spoke with Cathy Walker of the county auditor's office. It appears that Ms. Mackall is being charged for two parcels for the lighting assessment. Mr. Creasap's recommendation is that for the three homes located at 1811, 1823 and 1843 Grandview only be charged for one parcel for the lighting assessment. Mr. Creasap made the motion; seconded by Ms. McCleary. Motion carried. Ms. Perin will adjust the correspondence that is sent in August for this to Cathy Walker

The county prosecutor's office discussed with Ms. McCleary that the township cannot prohibit panhandling in the township due to free speech. Ms. McCleary will contact the deputy with the Sheriff's Dept. and report her findings.

Resolution for Marion Township 2024 Road Paving project

#### IN THE MATTER OF A RESOLUTION AUTHORIZING THE BOARD OF MARION TOWNSHIP TRUSTEES TO TAKE BIDS AND ENTER INTO CONTRACTS FOR THE PURPOSE OF PARTICPATING IN LOCAL TRANSPORTATION IMPROVEMENT PROGRAMS.

WHEREAS, Marion Township is planning to make or perform several road improvements for 2024 and

**WHEREAS,** these infrastructure improvements are considered to be priority needs for the community and are qualified projects within the Marion Township Road Department rotation list and

**WHEREAS,** road paving costs have been projected and estimated by the Marion County Engineer's Office for 2024, and

**WHEREAS,** legal notice will be published for bidding of said roads in local newspaper and specifications will be available on the Marion Township Website, <u>www.mariontwp.org</u> and by contacting the Marion Township Fiscal Officer, and

**THEREFORE, BE IT RESOLVED;** that the Chairman of the board of Marion Township Trustees, Mr. Larry Ballinger is hereby authorized to enter into contract, on behalf of the board, with the lowest bidding contractor, and that Mr. Roger Dietrich, Consultant will be the contact person for the road paving project.

**IT WAS MOVED BY;** Karen McCleary, seconded by Ben Creasap to authorize the board of Marion Township Trustees to enter into contract for the purpose of participating in the local transportation improvement project.

Vote on motion: Mr. Ballinger, yes; Mr. Creasap, yes; Ms. McCleary, yes.

**WHEREUPON** the resolution was declared adopted this 5th day of March 2024 and that bid opening is scheduled for April 2, 2024 at 5:30pm, at the meeting of the Marion Township Trustee.

Ms. Perin and Chief Meddles attended an insurance meeting with Dostel and Kirk and Craig Huebner, a rep from OTARMA. The group reviewed changes to the township's insurance coverage and Mr. Huebner recommended that Marion Township participate in a faithful performance of duty in lieu of separate bonds for each elected official. Resolution was read as follows:

# Resolution No. 2024-0305(B)

**WHEREAS** Marion Township, Marion County is a member of the Ohio Township Association Risk Management Authority (OTARMA), a political subdivision risk pool established pursuant to Ohio Revised Code hereinafter "ORC" 2744.081;

**WHEREAS** in accordance with ORC 3061, the township must adopt a policy by resolution to allow the use of an "employee dishonesty and faithful performance of duty" coverage document, rather than a surety bond, to cover loss by fraudulent or dishonest actions of employees and failure of employees to faithfully perform duties; the following shall apply to the policy:

- 1. An officer, employee, or appointee shall be considered qualified to hold the office or employment, without acquiring a bond, on the date the oath of office is taken, certified, and filed as required by law.
- 2. An officer, employee, or appointee shall have the employee dishonesty and faithful performance of duty policy in effect before the individual's term of office or employment and the officer, employee or appointee shall not commence the discharge of duties until coverage is documented.
- 3. All officers, employees, or appointees who would otherwise be required to file a bond before commencing the discharge of duties shall be covered by and are subject to the employee dishonesty and faithful performance of duty policy instead of a surety bond requirement.
- 4. The coverage amount for an officer, employee, or appointee under an employee dishonesty and faithful performance of duty policy shall be equal to or greater than the maximum amount of the bond otherwise required by law.
- 5. Elected officials, prior to taking the oath of office and holding office, shall obtain approval of the intent to use the township's OTARMA coverage agreement and affirm that the township's coverage complies with ORC 3061. Said approval shall be obtained by the Marion Township, Marion County.

**WHEREAS**, Marion Township, Marion County's "employee dishonesty and faithful performance of duty policy" through the OTARMA coverage document complies with ORC 3061; and

**NOW THEREFORE BE IT RESOLVED,** that on this 5<sup>th</sup> day of March 2024, the Marion Township, Marion County hereby authorizes the township to purchase and use "employee dishonesty and faithful performance of duty policy" through OTARMA instead of individual surety bonds for officers, employees, and appointees who are otherwise required by law to acquire a bond before entering upon the discharge of duties.

Ms. Perin asked for approval of the permanent appropriation resolution.

## **RESOLUTION 2024-0305**

# A RESOLUTION TO LIMIT ADULT USE CANNABIS OPERATORS WITHIN THE UNINCORPORATED AREA OF MARION TOWNSHIP, MARION COUNTY

**WHEREAS,** on November 7, 2023, voters in Ohio approved State Issue 2, which enacts new Chapter 3780 of the Ohio Revised Code, effective thirty (30) days from the date of election, and

**WHEREAS,** Chapter 3780 authorizes and regulates recreational adult-use cannabis in the state of Ohio; and

WHEREAS, O.R.C. 3780.25 authorizes townships to limit the number of adult-use cannabis operators (as defined in O.R.C. 3780.01) within the unincorporated area of the township; and WHEREAS, the Marion Township Board of Trustees finds it to be in the best interest of the township to limit adult-use cannabis operators licensed under O.R.C. Ch. 3780 within the unincorporated area of the township.

# NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- 1. All terms used in this resolution shall be defined in the same manner as O.R.C. Chapter 3780 as it pertains to adult-use cannabis. All terms used in this resolution but no defined in those chapters shall be construed, for purposes of this resolution, in a manner to be consistent with the use of such terms in both chapters
- 2. Adult use cannabis operators, which includes adult-use marijuana dispensaries, cultivators, and processors, are hereby limited to no more than one (1) operating within the unincorporated area of Marion Township, Marion County, Ohio

**THE AFORESAID** matter came before the Board of Trustees on March 5, 2024 for consideration. Mr. Ballinger, Trustee, made a motion to approve the resolution regarding limiting the number of adult-use cannabis operators to one (1) in the unincorporated area of Marion Township, Marion County, Ohio. The motion was seconded by Mr. Creasap. Roll call as follows: Mr. Ballinger, yes; Mr. Creasap, yes; Ms. McCleary, yes. Motion carried unanimously.
