Fire Department

Chief Meddles presented the latest promotional list to be approved by the board. The test was given by Command 352. Only 2 firefighters request to sit for the test and both passed. This list will be good for 4 years or until the list has been exhausted per CBA.

Still waiting to get quotes on paving of parking lots. Park Enterprise has been on vacation and will be meeting with chief week of July 7th. Chief will also be getting a couple other quotes.

The fire department secure lock devices are no longer supported and need to be replaced. This process will take place in stages, the first 3 will be done through the purchase of the new trucks and the remaining will be done next year. The new system requires a cloud subscription through Knox Box for around \$580 per year. This will allow the department to track the removal of the key for local businesses.

Ladder and pump testing were completed last month. Chief is waiting for report to come back.

Chief contacted RC Cooper over the status of the exterior repair for twp. hall. Seems there is a very big disconnect as to what and when this was going to take place. Joe was waiting on something official from the board to move forward. Doesn't seem like anything has been ordered. Chief told Joe to contact Fiscal to satisfy the contract for this work. Not sure if that has taken place yet.

Chief extended a job offer to Jonathan Hasson, he accepted the offer and has been going through the onboarding process. Not 100% on start date as there is some issues obtaining his physical agility testing requirement.

Nothing new to report on ordered trucks.

With no further business to discuss, Mr. Ballinger made a motion to adjourn; Ms. McCleary seconded. The motion carried and the meeting adjourned at 6:13 pm.
